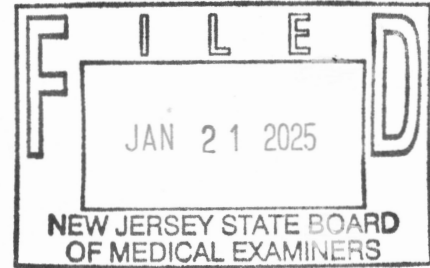

This matter has been opened to the New Jersey State Board of Medical Examiners ("Board") upon receipt of information that on or about November 21, 2024, a criminal complaint was issued in Jersey City, New Jersey, regarding Humberto T. Perez, M.D., License No. 25MA02353300 ("Respondent") alleging that Respondent engaged in sexual assault in violation of N.J.S.A. 2C:14-2C(1) and/or criminal sexual contact in violation of N.J.S.A. 2C:14-3b. Both offenses are alleged to have occurred with a patient during a medical examination. Based on that information, the Board opened an inquiry.

The allegations, if proven, would demonstrate that Respondent violated N.J.S.A. 45:1-21(c), (d), (e), (f), and (h), specifically N.J.A.C. 13:35-6.3.

In the interest of avoiding further proceedings and additional costs, and without any admission of wrongdoing, Respondent now seeks leave to permanently retire from the practice of medicine in New Jersey with such retirement to be deemed a permanent revocation. This retirement will fully resolve the current Board inquiry.

The parties being desirous of entering into a final resolution of this matter, and it appearing that Respondent, with the assistance of counsel, has read the terms of the within Consent Order and understands their meaning and effect and consents to be bound by same, and the Board finding that the within disposition is adequately protective of the public health, safety, and welfare, and for good cause shown,

IT IS, therefore, on this 21st day of JANUARY, 2025

ORDERED THAT:

1. Respondent, Humberto T. Perez, M.D., is hereby granted leave to retire his license to practice medicine and surgery in the State of New Jersey, with such retirement to be deemed a permanent revocation, effective the close of business on Friday, January 31, 2025.

2. The revocation of Respondent's license shall be permanent, and Respondent shall not have the right to reapply for a New Jersey medical license or to seek a Controlled Dangerous Substances ("CDS") registration in New Jersey at any time in the future.

3. In order to permit adequate care and transfer of Respondent's patients, this Consent Order shall take effect as of the close of business on January 31, 2025. Until that time, Respondent shall be permitted to see, examine, treat, or otherwise offer medical services to any of his current patients. Respondent shall not engage in the assessment, examination, treatment, or provision of other medical services to persons not under his care as of the date of this Order. From now until January 31, 2025, Respondent shall take

measures to wind down his medical practice. It is recognized that Respondent may issue prescriptions and that refills for prescriptions may be filled by patients after January 31, 2025.

4. The practice wind down permitted in the preceding paragraph is agreed to with the specific understanding of the Board that Respondent is permitted to see patients only with a chaperone present, pursuant to the conditions imposed upon him by the New Jersey Superior Court, Criminal Division as a part of his November 21, 2024, pre-trial release from custody.

5. Respondent shall cease and desist from all patient contact at any location and the rendering of medical care, including but not limited to the prescribing of CDS, effective the close of business on Friday, January 31, 2025.

6. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall return, either in person or by certified mail, his original New Jersey medical license, his current biennial registration, and his New Jersey CDS registration to Antonia Winstead, Executive Director, New Jersey State Board of Medical Examiners, P.O. Box 183, Trenton, New Jersey 08625-0183.

7. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall provide written notification to the United States Drug Enforcement Administration (the "DEA") of this Consent Order and provide proof to the Board that such notice was given to the DEA.

8. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall return his remaining prescription blanks, along with a cover memorandum indicating that he will no longer be writing prescriptions and asking that his prescription blanks be destroyed pursuant to standard operating procedures, to Dana Pulizzano, Executive

Director, Drug Control Unit, P.O. Box 45045, Newark, NJ 07101, either in person or by certified mail.

9. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall comply with N.J.A.C. 13:35-6.5(h), the Board regulation for practice closure. Respondent is to notify Antonia Winstead, Executive Director, State Board of Medical Examiners, 140 East Front Street, P.O. Box 183, Trenton, New Jersey 08625-0183 as to where his patient records are secured, and how patients may obtain them.

10. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall be precluded from managing, overseeing, supervising, or influencing the practice of medicine or provision of healthcare activities, including by testifying as an expert witness or being retained as a consulting expert, in the State of New Jersey.

11. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall not enter the premises of his former medical practice during business hours when patients may be present.

12. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall not charge, receive, or share in any fee for professional services rendered by others. Respondent shall be permitted to collect accounts receivable with respect to professional services that he rendered prior to the date he signs this Consent Order.

13. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall divest himself from any current and future financial interest in, or benefit derived from, the practice of medicine in the State of New Jersey.

14. Effective immediately after the close of business on Friday, January 31, 2025, Respondent shall comply with the "Directives Applicable to Any Medical Board Licensee who


is Disciplined or Whose Surrender of Licensure or Cessation of Practice has been Ordered or Agreed Upon,” which are attached hereto as Exhibit 1.

15. This Consent Order shall be a full and final disposition of the Board’s present investigation of Respondent. The Board shall retain jurisdiction to enforce the terms of this Consent Order.

16. The parties hereby stipulate that entry of this Consent Order is without prejudice to further action or investigation by this Board, the Attorney General, the Drug Control Unit, the Director of the Division of Consumer Affairs, or other law enforcement resulting from any conduct by Respondent prior to the entry of this Consent Order including, but not limited to, any pending matters under investigation unrelated to the allegations enumerated in the criminal complaint issued in Jersey City, New Jersey, on November 21, 2024, regarding Humberto T. Perez, M.D., License No. 25MA02353300 (“Respondent”). This Consent Order shall be a full and final resolution by this Board of all violations and facts expressly referenced in this Order.


17. Respondent enters into this Consent Order knowingly and voluntarily and acknowledges that there have been no other representations or agreements not stated in writing herein.



EXHIBIT 1

DIRECTIVES APPLICABLE TO ANY MEDICAL BOARD LICENSEE WHO IS DISCIPLINED OR WHOSE SURRENDER OF LICENSURE OR CESSATION OF PRACTICE HAS BEEN ORDERED OR AGREED UPON

APPROVED BY THE BOARD ON AUGUST 12, 2015

All licensees who are the subject of a disciplinary order or surrender or cessation order (herein after, "Order") of the Board shall provide the information required on the addendum to these directives. Failure to provide the information required may result in further disciplinary action for failing to cooperate with the Board, as required by N.J.A.C. 13:45C-1 et seq: Paragraphs 1 through 4 below shall apply when a licensee is suspended, revoked, has surrendered his or his license, or entered into an agreement to cease practice, with or without prejudice, whether on an interim or final basis. Paragraph 5 applies to licensees who are the subject of an order which, while permitting continued practice, contains probationary terms or monitoring requirement.

1. Document Return and Agency Notification

The licensee shall promptly forward to the Board office at Post Office Box 183, 140 East Front Street, 2nd floor, Trenton, New Jersey 08625-0183, the original license, current biennial registration and, if applicable, the original CDS registration. In addition, if the licensee holds a Drug Enforcement Agency (DEA) registration, he or she shall promptly advise the DEA of the licensure action. (With respect to suspensions of a finite term, at the conclusion of the term, the licensee may contact the Board office for the return of the documents previously surrendered to the Board).

Prior to the resumption of any prescribing of controlled dangerous substances, the licensee shall petition the Director of Consumer Affairs for a return of the CDS registration if the basis for discipline involved CDS misconduct. In addition, at the conclusion of the term, the licensee should contact the DEA to advise of the resumption of practice and to ascertain the impact of that change upon his/his DEA registration).

2. Practice Cessation

The licensee shall cease and desist from engaging in the practice of medicine in this State. This prohibition not only bars a licensee from rendering professional services, but also from providing an opinion as to professional practice or its application, or representing him/herself as being eligible to practice. (Although the licensee need not affirmatively advise patients or others of the revocation, suspension, surrender or cessation, the licensee must truthfully disclose his/his licensure status in response to inquiry.) The licensee subject to the order is also prohibited from occupying, sharing or using office space in which another licensee

provides health care services. The licensee subject to the order may contract for, accept payment from another licensee for rent at fair market value for office premises and/or equipment. In no case may the licensee subject to the order authorize, allow or condone the use of his/his provider number by any health care practice or any other licensee or health care provider. In situations where the licensee has been subject to the order for less than one year, the licensee may accept payment from another professional who is using his/his office during the period that the licensee is (suspended), subject to the order for the payment of salaries for office staff employed at the time of the Board action.

A licensee whose license has been revoked, suspended or subject to a surrender or cessation order for one (1) year or more must immediately take steps to remove signs and take affirmative action to stop advertisements by which his/his eligibility to practice is represented. The licensee must also take steps to remove his/his name from professional listings, telephone directories, professional stationery, or billings. If the licensee's name is utilized in a group practice title, it shall be deleted. Prescription pads bearing the licensee's name shall be destroyed. A destruction report form obtained from the Office of Drug Control (973-504-6558) must be filed. If no other licensee is providing services at the location, all medications must be removed and returned to the manufacturer, if possible, destroyed or safeguarded. (In situations where a license has been suspended for less than one year, prescription pads and medications need not be destroyed but must be secured in a locked place for safekeeping.)

3. Practice Income Prohibitions/Divestiture of Equity Interest in Professional Service Corporations and Limited Liability Companies

A licensee subject to the order shall not charge, receive or share in any fee for professional services rendered by him/herself or others while barred from engaging in the professional practice.¹ The licensee may be compensated for the reasonable value of services lawfully rendered and disbursements incurred on a patient's behalf prior to the effective date of the Board order.

This bar on the receipt of any fee for professional services is not applicable to cease and desist orders where there are no findings that would be a basis for Board action, such as those entered adjourning a hearing.

A licensee who is a shareholder in a professional service corporation organized to engage in the professional practice, whose license is revoked, surrendered or suspended or who is ordered to cease practice for a term of one (1) year or more shall be deemed to be disqualified from the practice within the meaning of the Professional Service Corporation Act. (N.J.S.A. 14A:17-11). A disqualified licensee shall divest him/herself of all financial interest in the professional service corporation pursuant to N.J.S.A. 14A:17-13(c). A disqualified licensee who is a member of a limited liability company organized pursuant to N.J.S.A. 42:1-44, shall also divest him/herself of all financial interest. Such divestiture of the licensee's interest in the limited liability company or professional service corporation shall occur within 90 days following the entry of the order rendering the licensee disqualified to participate in the

applicable form of ownership. Upon divestiture, a licensee shall forward to the Board a copy of documentation forwarded to the Division of Revenue and Enterprise Services demonstrating that the interest has been terminated. If the licensee is the sole shareholder in a professional service corporation or sole member of the limited liability company, the corporation must be dissolved within 90 days of the licensee's disqualification unless it is lawfully transferred to another licensee and documentation of the valuation process and consideration paid is also provided to the Board.

4. Medical Records

If, as a result of the Board's action, a practice is closed or transferred to another location, the licensee shall ensure that (during the three (3) month period) immediately following the effective date of the disciplinary order, a message will be delivered to patients calling the former office premises, advising where records may be obtained. The message should inform patients of the names and telephone numbers of the licensee (or his/his attorney) assuming custody of the records. The same information shall also be disseminated by means of a notice to be published at least once per month for three (3) months in a newspaper of general circulation in the geographic vicinity in which the practice was conducted. If the licensee has a website, a notice shall be posted on the website as well.

At the end of the three-month period, the licensee shall file with the Board the name and telephone number of the contact person who will have access to medical records of former patients. Any change in that individual or his/his telephone number shall be promptly reported to the Board. When a patient or his/his representative requests a copy of his/his medical record or asks that record be forwarded to another health care provider, the licensee shall promptly provide the record without charge to the patient.

5. Probation/Monitoring Conditions

With respect to any licensee who is the subject of any order imposing a probation or monitoring requirement or a stay of an active suspension, in whole or in part, which is conditioned upon compliance with a probation or monitoring requirement, the licensee shall fully cooperate with the Board and its designated representatives, including the Enforcement Bureau of the Division of Consumer Affairs, in ongoing monitoring of the licensee's status and practice. Such monitoring shall be at the expense of the disciplined practitioner.

(a) Monitoring of practice conditions may include, but is not limited to, inspection of the professional premises and equipment, and inspection and copying of patient records (confidentiality of patient identity shall be protected by the Board) to verify compliance with the Board Order and accepted standards of practice.

(b) Monitoring of status conditions for an impaired practitioner may include, but is not limited to, practitioner cooperation in providing releases permitting unrestricted access to records and other information to the extent permitted by law from any treatment facility, other treating

practitioner, support group or other individual/facility involved in the education, treatment, monitoring or oversight of the practitioner, or maintained by a rehabilitation program for impaired practitioners. If bodily substance monitoring has been ordered, the practitioner shall fully cooperate by responding to a demand for breath, blood, urine or other sample in a timely manner and providing the designated sample.

6. Payment of Civil and Criminal Penalties and Costs.

With respect to any licensee who is the subject of any order imposing a civil penalty and/or costs, the licensee shall satisfy the payment obligations within the time period ordered by the Board or be subject to collection efforts or the filing of a certificate of debt. The Board shall not consider any application for reinstatement nor shall any appearance before a committee of the Board seeking reinstatement be scheduled until such time as the Board ordered payments are satisfied in full. (The Board at its discretion may grant installment payments for not more than a 24 months period.)

As to the satisfaction of criminal penalties and civil forfeitures, the Board will consider a reinstatement application so long as the licensee is current in his or his payment plans.

**NOTICE OF REPORTING PRACTICES OF BOARD
REGARDING DISCIPLINARY ORDERS/ACTIONS**

All Orders filed by the New Jersey State Board of Medical Examiners are "government records" as defined under the Open Public Records Act and are available for public inspection, copying or examination. See N.J.S.A. 47:1A-1, et seq., N.J.S.A. 52:14B-3(3). Should any inquiry be made to the Board concerning the status of a licensee who has been the subject of a Board Order, the inquirer will be informed of the existence of the Order and a copy will be provided on request. Unless sealed or otherwise confidential, all documents filed in public actions taken against licensees, to include documents filed or introduced into evidence in evidentiary hearings, proceedings on motions or other applications conducted as public hearings, and the transcripts of any such proceedings, are "government records" available for public inspection, copying or examination.

Pursuant to N.J.S.A. 45:9-22, a description of any final board disciplinary action taken within the most recent ten years is included on the New Jersey Health Care Profile maintained by the Division of Consumer Affairs for all licensed physicians. Links to copies of Orders described thereon are also available on the Profile website. See <http://www.njdoctorlist.com>.

Pursuant to federal law, the Board is required to report to the National Practitioner Data Bank (the "NPDB") certain adverse licensure actions taken against licensees related to professional competence or conduct, generally including the revocation or suspension of a license; reprimand; censure; and/or probation. Additionally, any negative action or finding by the Board that, under New Jersey law, is publicly available information is reportable to the NPDB, to include, without limitation, limitations on scope of practice and final adverse actions that occur in conjunction with settlements in which no finding of liability has been made. Additional information regarding the specific actions which the Board is required to report to the National Practitioner Data Bank can be found in the NPDB Guidebook issued by the U.S. Department of Health and Human Services in April 2015. Pursuant to N.J.S.A. 45:9-19.13, in any case in which the Board refuses to issue, suspends, revokes or otherwise places conditions on a license or permit, the Board is required to notify each licensed health care facility and health maintenance organization with which a licensee is affiliated and every other board licensee in this state with whom he or she is directly associated in private medical practice.

In accordance with an agreement with the Federation of State Medical Boards of the United States, a list of all disciplinary orders entered by the Board is provided to the Federation on a monthly basis.

From time to time, the Press Office of the Division of Consumer Affairs may issue press releases including information regarding public actions taken by the Board.

Nothing herein is intended in any way to limit the Board, the Division of Consumer Affairs or the Attorney General from disclosing any public document.
