He restated the concerns submitted by the Ad Hoc Committee in response to the proposed re-adoption of the Board's regulation including: N.J.A.C. 13:28-1.1(e)-application for teacher license-proof of work experience (minimum 30 hour a week); N.J.A.C. 13:28-1.3-temporary and student permits; N.J.A.C. 13:28-2.1-application for facility license; N.J.A.C. 13:28-2.1(iv)-physical requirements; N.J.A.C. 13:28-6.20-clinical uniform; N.J.A.C.13:28-6.21-leave of absence from school; N.J.A.C. 13:28-6.27(f); and N.J.A.C. 13:28-3.2- the cost of filtering water.
