

NOVEMBER 5, 2014

The Board Minutes of November 5, 2014, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of December 3, 2014, or soon thereafter as it may be considered. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Board meeting of November 5, 2014, was called to order at 9:00 A.M.

Marian Fiore, Senior Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, was present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (13) Initial Licenses effective November 5, 2014 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (27) Initial Business Permits effective November 5, 2014 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (2) Initial Business Permits Previously Expired effective November 5, 2014 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (7) Changes in Business Permits effective November 5, 2014 to March 31, 2015.

Money Order in the amount of \$200.00 received from Christian F. Rupp, License #8149, t/a CR Electrical Contracting, as the eighteenth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$700.00.

The Board accepted the payment.

Personal Money Order in the amount of \$1,000.00 received from Arnold Chernin, License #192 (Revoked), as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:31-3.5 and N.J.A.C. 13:31-3.3(b).

The Board accepted the payment.

Letter dated September 16, 2014, received from Brian C. Darreff, Esq., requesting a six-month continuance of business under Permit #13892 according to N.J.S.A. 45:5A-14. The licensee, James S. Diamond, died on August 30, 2014.

Mr. Darreff stated Dylan G. Alexander has been with the company since 2006 and has been approved to take the electrical contractor's examination.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the firm of Diamond Technologies, LLC be granted a six-month continuance of business under permit #13892 according to N.J.S.A. 45:5A-14.

The Board approves Dylan G. Alexander to qualify the business for the six-month period.

Letter dated October 6, 2014, received from Michael Dillon requesting a six-month continuance of business under Permit #13401 according to N.J.S.A. 45:5A-14. The licensee, Kevin L. Cranmer, died on August 22, 2014.

Mr. Dillon stated his stepson, Michael Dillon, has worked for the company since 2004 and has been approved to take the electrical contractors examination.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the firm of Shore Point

Electric be granted a six-month continuance of business under permit #13401 according to N.J.S.A. 45:5A-14. The Board approves Michael Dillon to qualify the business for the six-month period.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Richard F. Van Wert, Electric Education Center, requesting approval of one new instructor to teach previously approved courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, that a letter be sent to Mr. Van Wert requesting a more detailed resume/curriculum vitae for the new instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Leah Aleixo, National Fire Protection Association, requesting approval of three new instructors to teach previously approved courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to approve Ms. Aleixo's request to add new instructors to teach previously approved courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Sarah Barton, Warshauer Electric Supply, requesting approval of a new instructor for a previously approved course.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to approve Ms. Barton's request to add a new instructor to teach previously approved courses.

David Freed stated PSI will administer the examination beginning in January 2015. The examination content outline was previously sent to the Board for its' review.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the examination content outline submitted by PSI.

Ron Kraza, Esq. appeared with his client Christian Aruajo to discuss with the Board the difficulties his client encountered on the day of the examination.

Mr. Aruajo stated Prometric did not provide him with the 2014 Code Book; therefore, he had to use the 2011 Code Book. Mr. Aruajo also

stated some of the questions on the examination required the use of a 2014 Code Book. Mr. Aruajo further stated he passed the fire alarm portion, but received a 68 on the Code portion and the Business and Law portion of the test.

Mr. Aruajo stated he sat in the hallway to take the Code portion of the examination and as applicants were exiting the testing room they stopped and talked to him interrupting his concentration as he was trying to complete the test.

Mr. Aruajo stated for the second portion of the examination, he was told to find a place in the examination room and, without a break, immediately took the business and law portion of the examination.

Mr. Aruajo also stated he was not allotted the appropriate time to complete the test, and he did not start at the same time as the other applicants as Prometric did not have his paperwork.

Mr. Aruajo stated he did receive an e-mail advising that the examination date was October 7; however, all the other documentation indicated October 6, 2014.

Mr. Freed stated the documentation does reflect that the examination is scheduled for October 6, 2014; however, there is a notation on the registration form that indicates if there is a large number of candidates, applicants may be scheduled for the next day.

Mr. Aruajo stated he would like to be allowed to take the examination without waiting the six month period because of the circumstances he endured.

Mr. Schooley advised Mr. Aruajo that the Board will deliberate and he will receive an answer in writing.

E-mail dated October 20, 2014, received from Alan Chech, stating he issued one certificate to each contractor/journeyman reflecting the seven courses they attended. Mr. Chech is asking whether or not this certificate is sufficient, or must he send a separate certificate for each course attended.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that a letter be sent to Mr. Chech advising him that the Board has denied his request. Mr. Chech will be advised that he must follow the procedures established and issue a separate certificate for each course completed.

Joseph P. Schooley, Chairman, signed on this date, a Final Order of Discipline ordering that Jack A. Giaimo, License #7375 (Expired), pay a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:1-21(e) and License and Business Permit #7375 are suspended until

such time as Mr. Giaimo applies for reinstatement, appears before the Board to discuss the complaint received from Carl Attisano, Electrical Subcode Official for the City of Bayonne, satisfies all the requirements and qualifications for reinstatement, and has fully satisfied all the penalties assessed. Mr. Giaimo is also required to surrender to the Enforcement Bureau the pressure seal issued to Powermaster Electric, Business Permit #7375.

Joseph P. Schooley, Chairman, signed on this date a Final Decision and Order on Default ordering that Kevin P. Karcich pay a civil penalty in the amount of \$18,775.00 for violation of N.J.S.A. 45:5A-9 and cease and desist from the unlicensed practice of electrical contracting.

The Board reviewed applications for the written examination. Fourteen (14) applications were approved.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
