

**781 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS  
(PUBLIC SESSION) - - - JANUARY 5, 2005**

The Board Minutes of January 5, 2005, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of February 2, 2005. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Meeting of January 5, 2005 was called to order at 9:00 A.M.

Barbara A. Cook, Executive Director, was present from 9:00 A.M. until the close of the meeting.

Alok Jain, Personal Assistant for the Executive Director, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Secretarial Assistant, III, was present from 9:00 until the close of the meeting.

Susan Carboni, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance were Mr. James Bibbo, Central Jersey Electrical League and Edward Osoliniec, License #8973.

The Board saluted the flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed to approve the Minutes of the Special Meeting held November 10, 2004.

The Minutes of the 779 Meeting held November 3, 2004, and the Minutes of the 780 Meeting were not available for approval by the Board.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (19) Initial Licenses effective January 5, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (17) Initial Business Permits effective January 5, 2005 to March 31, 2006.

At its meeting of April 7, 2004, the Board held in abeyance the request of Brad Darnell to endorse his Business Permit #15274 to Deem A. Mechanical and Electrical, LLC.

The Board received a civil penalty payment from Deem A. Mechanical and Electrical, LLC. in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the issuance of an Initial Business Permit to Deem A. Mechanical and Electrical, LLC effective January 5, 2005 to March 31, 2006 as follows:

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (5) Initial Business Permits Previously Expired effective January 5, 2005 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (11) Changes in Business Permits Previously Expired effective January 5, 2005 to March 31, 2006.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the twenty-fourth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.A.C. 13:31-1.8(b) (recodified as N.J.A.C. 13:31-3.2(b)). Payments started September 25, 2002, and the balance due is \$1,900.00.

The Board accepted the payment.

The Board reviewed an application for reinstatement received from Joseph Regan as he failed to renew his License #9191 for the 1991 to 1994; 1994 to 1997; 1997 to 2000; 2000 to 2003; 2003 to 2006 triennial renewal periods.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Regan advising him that the Board has voted to reinstate his license #9191 with the payment of the proper fees and contingent upon receipt of the first penalty payment in the amount of \$1,000.00 pursuant to the signed Consent Order.

Letter dated November 22, 2004, received from Dominick M. Yanetta requesting a third six-month continuance of business under permit #1109 according to N.J.S.A. 45:5A-14. The licensee, Angelo Yanetta, died on August 7, 2003.

Mr. Yanetta stated that he is scheduled to retake the examination in April 2005.

The current extension expires on February 21, 2005.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Gail Best, and unanimously passed, that a letter be sent to Dominick M. Yanetta advising him that the Board has granted the firm of Yanetta Electric Company, Inc., a third and final six-month continuance of Business Permit #1109 according to N.J.S.A. 45:5A-14. Mr. Yanetta will be advised that this is the final extension being granted to Yanetta Electric Company, Inc. Therefore, if necessary, he should make arrangements with a licensed electrical contractor with a business permit to complete any unfinished jobs after the extension has expired.

Letter dated December 16, 2004, received from Robert W. Lessner, Vice President/Secretary of Lessner Electric, requesting a six-month continuance of business under permit #609 according to N.J.S.A. 45:5A-14. The licensee, Sidney F. Lessner, died on December 9, 2004.

Mr. Lessner stated that he has been with Lessner Electric since March of 1980 and will shortly submit his application to take the electrical contractor's examination.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, that a letter be sent to Robert W. Lessner, Vice President/Secretary, advising him that the Board has granted the

firm of Lessner Electric a six-month continuance of Business Permit #609 according to N.J.S.A. 45:5A-14.

The sub-committee reviewed additional information for Continuing Education Course/Seminar approval from Adrian Estes, International Board of Environmental Health & Safety, Inc., requesting approval of new courses.

At its meeting held on October 6, 2004, the course entitled "Making Safety Work for You" was held in abeyance pending clarification of the 45 minute overlap concerning the two topics listed on the Program Agenda. Key 2 of the 5 Keys to Safety is taught from 10:15 until 11:45 and Key 3 of the 5 Keys is being taught from 11:00 until 11:45. The course entitled "OSHA 10 Hour - Construction" was denied as it does not meet the criteria of Continuing Education which stipulates that only 8 instructional hours can be taught in one day.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructor, are approved as submitted.

"Fundamentals of Occupational Safety"

"Making Safety Work for You"

"OSHA 10 Hour - Construction"

The sub-committee reviewed additional information for Continuing Education Course/Seminar approval received from Gay E. Canough, ETM Solar Works, requesting approval of a new course.

At its meeting held on October 6, 2004, the course entitled "Photovoltaics (PV) Installer's Course" was being held in abeyance pending a breakdown of the hours for each of the topics listed in the course syllabus. Dr. Canough was advised that review and study time is not to be included as part of the hours of instruction.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following course, and instructor, is approved as submitted.

"Potovoltaics (PV) Installer's Course"

The sub-committee reviewed additional information for Continuing Education Course/Seminar approval received from John Biondi, Joint Apprenticeship Training Committee, requesting approval of new courses.

At its meeting held October 6, 2004, Mr. Biondi's request was again denied as some of the courses submitted do not meet the criteria of Continuing Education. Continuing Education courses are for the prime purpose of educating licensed electrical contractors. For example the course entitled "Conduit Bending and Welding" is not a course that a licensed electrical contractor would be required to attend; however, the course entitled "OSHA 10/30 Hour Training and Electrical Grounding" would be a course that meets the criteria of Continuing Education. Additionally, some of the courses submitted by Mr. Biondi did not specify exact hours; they were approximated. Mr. Biondi was also advised to provide the Board with a more detailed breakdown and description of the course content.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Biondi advising him that his request is again denied as he did not specify the exact hours to be taught. The courses entitled "Industrial Motor Controls"; "Code Calculations"; and "Blueprint Reading" do not indicate specific hours of instruction. The course entitled "Corning Training" does not specify the number of hours of instruction. Additionally, the Board feels that the courses for which Mr. Biondi is seeking approval do not include enough of a description. Mr. Biondi will be asked to provide the Board with a detailed description/breakdown of the course content and the exact hours of instruction.

The sub-committee reviewed the application for Continuing Education Course/Seminar approval received from Robert Marshall, Capital Community College, requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Marshall advising him that his request is being held in abeyance pending receipt of a

detailed description/breakdown of the hours to be taught in each subject matter.

The sub-committee reviewed the application for Continuing Education Course/Seminar approval received from Ralph Lombardi.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructor, are approved as submitted. Mr. Lombardi's request to teach the nine hours of code changes and one hour of business and law is approved.

"Industrial Controls"

"Grounding"

"Hazardous Locations"

"Wiring Methods"

"Swimming Pools, Spas and Hot Tub Wiring"

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Kathleen L. Moskowitz, New Jersey Electrical Contractors Association.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the following courses, and instructors, are approved as submitted.

"Prevailing Wages"

"Managing Work Force"

"Safety Services"

The following course is being held in abeyance pending a course description which was not included.

+ "Business and Marketing"

The Board reviewed a memorandum received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the first quarter of Fiscal Year 2005, the board/committee was directly billed for 144.1 hours of Deputy Attorney General/Paralegal services totaling \$14,886.65.

Signed cease and desist agreement was received from Brandon M. Hill, Mantua, New Jersey.

The Board accepted the signed cease and desist agreement.

Ralph R. Freudeman, License #8485, has failed to respond to the Administrative Action Provisional Order of Discipline filed October 6, 2004 ordering that Mr. Freudeman be assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9.

Certified mail returned "Unclaimed", regular mail not returned.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that Deputy Attorney General Susan Carboni prepare a Final Order of Discipline ordering that Mr. Freudeman be assessed a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9.

Barbara A. Cook advised the Board that she was notified yesterday that the proposed rule N.J.A.C. 13:31-3.5 "Joint Ventures; Subcontracting of Electrical Work" will be published for comment in the New Jersey Register in February 2005.

Mr. Bibbo asked the Board when licensed burglar and fire alarms installers should start presenting/advertising their license numbers.

Mr. Schooley stated that it will take perhaps up to one year before licensees will be required to present/advertise their license as the Business Licensees have yet to be issued.

+ Mr. Osoliniec stated that he is an approved continuing education instructor and it is not clear to him if he needs to again be approved to teach the nine hours of code changes and the one hour of law. Mr. Osoliniec also stated that there are many instructors who are already advertising their courses. Mr. Osoliniec further stated that he has not started advertising because he has not been pre-approved by the Board.

The Board held a brief discussion without the public being present.

Mr. Schooley stated that the Board has decided to give a blanket approval to all previously approved code and law instructors to begin teaching the 2005 Continuing Education Code Courses. Letters will be sent to all previously approved instructors advising of same. The instructors will also be advised of the required \$100.00 fee if they have not already paid same. A packet of information will then be mailed to all interested instructors.

The Board reviewed applications for the written examination to be administered by Expor Assessment, LLC. Ten (10) applications were approved.

Motion made by Mrs. Gail Best and seconded by Mr. Robert A. McCullough, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
