The Board saluted the Flag.

Mr. Schooley requested a moment of silence for Michael J. Dominach who passed away on May 31, 2010. Mr. Dominach was a Paralegal for the Board of Dentistry.

June 2, 2010

Mr. Richard T. Aicher, Jr. abstained from the following motion as he was not in attendance for the May 5, 2010 Meeting.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and passed, to approve the Minutes of the 843rd Open Session Business Meeting held May 5, 2010 with the following correction:

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (35) Initial Business Permits effective June 2, 2010 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (2) Initial Business Permits Previously Expired effective June 2, 2010 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (5) Changes in Business Permits effective June 2, 2010 to March 31, 2012.

Check in the amount of \$60.13 received from Mark Wiggins, License #10860, t/a Wiggins Electric, as the seventh and final installment of a civil penalty in the amount of \$1,511.53 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

June 2, 2010

Check in the amount of \$500.00 received from Peter Virilli, Unlicensed, as the first and final payment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Check in the amount of \$100.00 received from William J. Passione, License #11485, t/a B Passione Electric, as the fifth installment of a civil penalty in the amount of \$3,500.00 for violation of N.J.S.A. 45:5A-9; N.J.S.A. 56:8-1 et seq; and N.J.A.C. 13:45C-1.2. Payments started February 4, 2010 and the balance due is \$3,000.00.

The Board accepted the payment.

Cashier's Check in the amount of \$150.00 received from Ronald Masterson, License #9128, t/a Masterson Electrical, Inc., as the tenth and final installment of a civil penalty in the amount of \$1,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 45:5A-15.

The Board accepted the payment.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Richard Paredes.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Mitchell R. Malec, and unanimously passed, that all previously approved courses are approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Michele Powell, New Jersey Electrical Contractors Assoc.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Ms. Powell advising her that the course entitled "Lead Certification" is not approved as presented as the entire course does not meet the criteria of Continuing Education. However, the electrical portion of this course appears to contain 2 hours of material that would relate to the field of electrical contracting. Therefore, the Board will allow two hours to be credited towards continuing education for electrical contractors.

June 2, 2010

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Bernie Corrigan, IBEW Local 102.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve six (6) new courses and instructors and previously approved courses and instructors.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Mervin Munoz, IEC Chesapeake.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve seven (7) new courses and instructors. The Board also approved Mr. Munoz's request to add instructors to previously approved courses.

Adoption of Qualified Journeyman Electrician was published in the New Jersey Register May 17, 2010, amending N.J.A.C. 13:31-5.1(a 2) to include the language that the practical experience gained shall have been done in compliance with the National Electrical Code, and who has had a minimum of 576 classroom hours of related instruction.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirty-five (35) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred.
