Ginger R. Provost, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve the Minutes of the Special Meeting held September 20, 2006. Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 802 Meeting held October 4, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (10) Initial Licenses effective November 1, 2006, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (9) Initial Business Permits effective November 1, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (5) Initial Business Permits Previously Expired effective November 1, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (6) Changes in Business Permits effective November 1, 2006 to March 31, 2009.

Check in the amount of \$100.00 received from Michael Delli Santi, Unlicensed, as the eleventh installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 29, 2005 and the balance due is \$1,300.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Nick Ortense, Unlicensed, as the thirteenth installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 18, 2005 and the balance due is \$650.00.

The Board accepted the payment.

Check in the amount of \$50.00 received from Vernon Walderon, Unlicensed, as the fifth installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started July 17, 2006 and the balance due is \$250.00.

The Board accepted the payment.

Check in the amount of \$250.00 received from Kevin Smith, Unlicensed, as the first and final installment of a civil penalty in the amount of \$250.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Letter dated October 5, 2006, received from Stephen Seidel, President, Seidel Electric, Inc., requesting a second six-month continuance of business under permit #926 according to N.J.S.A. 45:5A-14. The licensee, Kurt Seidel, Jr., died February 26, 2006. The first extension expired on October 30, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Seidel advising him that the Board has granted the firm of Seidel Electric, Inc., a second six-month continuance of Business Permit #926 according to N.J.S.A. 45:5A-14.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Robert E. Lawless.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (12) new courses, and instructors, are approved as submitted. A letter will be sent to Mr. Lawless asking him if his courses entitled "National Electrical Code Update - 2005" and "New Jersey State Statutes and Regulations" are the required nine hours of code changes and the one hour of Laws, Rules and Regulations.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Marcel Renson.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (10) new courses, and instructors, are approved as submitted. The previously approved courses are also approved. Mr. Renson will be advised that the approval of the following courses is being held in abeyance pending a more detailed course outline, "National Electrical Code and The Energy Subcode"; "Rehab Subcode and The National Electrical Code"; "Article 555 Marinas and Boatyards" and "Introduction to the Uniform Construction Code".

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Anthony J. Neibert.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (3) new courses, and instructors, are approved as submitted. Mr. Neibert will be advised that the course entitled "Zoning/ADA Wiring Requirements" is being held in abeyance as the Board is not clear how many hours

will be spent on each topic. Additionally, since this course is only four hours in length, the Board requests a more detailed course content outline as each municipality, of which there are 566, have their own zoning laws.

The sub-committee reviewed a letter dated September 28, 2006, received from members of the New Jersey Contractors Educational Institute, Inc., concerning the denial of computer based courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that this matter be held in abeyance pending further review by the sub-committee.

The sub-committee reviewed a letter dated October 19, 2006, received from John A. Drebitko, New Jersey Electrical Group, Inc., requesting a second sponsor number in order to provide courses to others where his group may not be acceptable. Mr. Drebitko also requests that courses already approved for Merle Margolese, Instructor #490, be included under his sponsorship.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that Mr. Drebitko's requests are approved pending receipt of a completed Continuing Education Course/Seminar application for each request.

The Board reviewed the Fiscal Year 2006 Budget Report (final).

Mr. Aicher stated that it appeared that the Board was spending a lot of money on legal and enforcement fees, but it seems like we are only recovering a fraction of those costs. Mr. Aicher asked where in the report does it reflect the monies collected against what the Board is spending?

The Board requested that Darlene Kane be invited to discuss with it the budget report.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Ten (10) applications were approved.

Motion made by Mrs. Connie F. Calisti and seconded by Mr. Robert A. McCullough, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
