849th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) NOVEMBER 3, 2010

All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Meeting of November 3, 2010, was called to order at 9:00 A.M. The following members were present:

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance were Robert Jules, Central Jersey Electrical League; Walter Dubyna, Robert Spellman, and Robert McGowan, Members of the Electrical Contractors Association of New Jersey.

The Board saluted the Flag.	

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the Minutes of the 847th Open Session Business Meeting held September 1, 2010, with the following correction:

Page 2, paragraph 5

Check in the amount of \$100.00 received from William J. Passione, License #11485, as the eighth installment of a civil penalty in the amount of \$3,500.00 for violation of N.J.S.A. 45:5A-9; N.J.S.A. 56:8-1 et seq; and N.J.A.C. 13:45C-1.2. Payments started February 4, 2010 and the balance due is \$2,695.00.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (32) Initial Licenses effective November 3, 2010 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (32) Initial Business Permits effective November 3, 2010 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (4) Initial Business Permits Previously Expired effective November 3, 2010 to March 31, 2012.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (9) Changes in Business Permits effective November 3, 2010 to March 31, 2012.

Letter dated October 20, 2010, received from William E. Wilkie requesting a third six-month continuance of business under Permit #12257 according to N.J.S.A. 45:5A-14. The licensee, Michael P. Capparucci, died on December 5, 2009.

Mr. Wilkie has applied to retake the electrical contractor's examination scheduled for April 2011. Office files reflect that the second extension granted to Hi-Tech Electric will expire on December 7, 2010.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and passed, that a letter be sent to Mr. Wilkie advising him that the Board has granted the firm of Hi-Tech Electric an extension to do business until April 30, 2011. Should Mr. Wilkie pass

the April 2011 examination, the extension will be granted until the proper paperwork is submitted to the Board for approval of a license and business permit. Should Mr. Wilkie not pass the April 2011 examination, then the company must hire a licensed electrical contractor to endorse his business permit to Hi-Tech Electric to continue the business.

Mr. Mitchell R. Malec abstained from the motion.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Jill Heath, Harger Lightning & Grounding.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) Continuing Education Course and instructors.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Leah Aleixo, National Fire Protection Association.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) Continuing Education Course and instructors. Ms. Aleixo will be advised that licensed electrical contractors must attend all 21 hours in order to receive a certificate for the renewal of their license. The Board recommends that Ms. Aleixo include this language in their advertisements.

Charles Manning, Regulatory Analyst, appeared before the Board on October 6, 2010, to discuss language he drafted regarding the scope of practice of master HVACR Contractors.

After a brief discussion regarding the drafted language, the Board requested that Charles Manning, Regulatory Analyst, Division of Consumer Affairs, be requested to appear before it to further discuss this matter.

The Board discussed the definition of a dwelling unit as described in the National Electrical Code.

After a brief discussion, the Board requested that Maryann Sheehan, Regulatory Analyst,

appear before it to discuss defining the term "dwelling" as reflected in N.J.S.A. 45:5A-18(n).

The Board reviewed Assembly Bill No. 2394 which changes the definition of "electronic security system" contained in the law. The definition of "electronic security system" is expanded to include access security systems, closed circuit television systems, intercom systems and other electronic monitoring devices.

The Bill also establishes definitions in this law for "access control system", "closed circuit television system", "Internet protocol and any successor protocols" and "intercom systems".

Mr. Schooley stated that he received a telephone call from an individual from the IBEW concerning this bill as the individual did not know if the bill would impact licensed electrical contractors.

Mrs. Sheehan stated that the bill would remove the requirement that alarm companies respond in twenty-four hours and the requirement that they must have an office in this state. The committee supported the bill; however, the Division did not. The Division objected to the requirement for having an in state office which is not consistent with this administration.

Mrs. Sheehan stated that this bill has not been scheduled for another vote.

Mrs. Sheehan also stated that in regards to continuing education, she will submit the Board's request that the rules regarding N.J.A.C. 13:31-1.7(I) be amended to say that a sponsor of a course or program offering that has been previously approved by the Board shall reapply to the Board for approval of the course or program if there are any changes to the course content, hours of instruction, or course lecturer. The sponsor shall resubmit to the Board the documentation and continuing education sponsor fee set forth in N.J.A.C. 13:31-1.7 (h 2 & 5). If there are no changes in course content, hours of instruction, or course lecturer for a previously approved course or program, the sponsor shall not be required to reapply to the Board for approval prior to offering the course or program in a subsequent renewal period.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fourteen (22) applications were approved

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.

Meeting adjourned at 2:00 P.M.
