SENATE, No. 2100 / State of N.J. 212th Legislature Changes membership of Home Inspection Advisory Committee

The Committee reviewed the bill and agreed to support it with the following amendments: To change the number of CMs from 6 to 7 with 2 public members, 4 H.I.s and 1 PE.

ASSEMBLY, No. 3359 / State of N.J. 212th Legislature Revises "grandfathering" provisions for eligibility to be a licensed home inspector.

The Committee noted this bill that the grandfather clause has been extended several times already and most applicants have been licensed by December 30, 2005, thus, there is a sufficient number (over 500) of licensed home inspectors to handle the slowing market
