• My concern is that by using this material it increases the chances of contaminating the HVAC system with bacteria, molds, and other unwanted hazards including vermin.

Board Motion

On February 7, 2017, the Board discussed this issue and noted that the International Mechanical Code for 2015 includes a section for "gypsum ducts." An agreement was reached whereby Member Thomas C. Pitcherello will investigate the code and return to the Board with his findings.

Mr. Pitcherello has provided the section from the 2015 International Mechanical Code Commentary pertaining to gypsum ducts for Board review.

- 5- Tennessee
- 6- Alabama
- 7- Delaware

Below states do not have State-wide licensing and therefore, do not meet reciprocity requirements:

- 8- Pennsylvania
- 9- New York
- 10- Illinois
