The Board will continue to review the applications submitted in the "Reciprocity" category by considering the licensure standards of the other States. The Board must insure that those licensure standards are equal to, or comparable with, those of New Jersey, in compliance with N.J.A.C. 13:32A-2.5. This review was scheduled with DAG Donofrio and Regulatory Analyst Charles Manning and ten (10) states have been denied reciprocity:

Maryland, Texas, Ohio, Florida, Tennessee, Alabama, Delaware, Pennsylvania, New York, Illinois

I will retire in 3 years and want to know what is allowed or not allowed.

I have a question regarding the permits required to replace boilers since the introduction of the Master HVACR license.

Some townships only require mechanical permits, others are still requiring me to contract plumbers for non-testable backflow preventers and electricians for the reconnect 220v and under.

Can you clarify the correct procedure? Do I fill out the plumbing and electrical marking the exempt status? Most of our business is emergency service and we do very little system replacements, but we do them from time to time. This process has always been a frustrating part of the HVACR industry in New Jersey and I had hoped the Master HVACR license would alleviate these frustrations, but in some respects it is even more confusing.

Today I was informed by a Neptune township electrical inspector, that our Master HVAC license is basically nothing. The inspector could not understand what the Master HVAC stamp meant. This inspector has an issue with the license and with us performing any work that evolves electrical.

Now, according to the rules that I have, under the guidelines, 13:32A-1.2 Definitions 10. i-iii for replacement only, we are allowed to connect the electrical of equipment 25 Tons or less, and 240 volts or less.

Can you please inform me if the rules have changed since 12/21/2015 and if so, what the changes may be now? Thank you so much for your help in the matter.
