Based on the terms of his Consent Order, the applicant agrees to a psychosexual evaluation. Credentials of his intended evaluator are submitted for Board consideration.

The Board reserves the right to proceed into Executive Closed Session to discuss the credentials of the evaluator intended to conduct the psychiatric evaluation of the applicant in consideration of an HVACR license.

On February 7, 2017, a motion was made by Paul J. Mitchell and seconded by Daniel G. Danko, Jr., as follows, that the Board considered the credentials of this evaluator and agreed to permit this evaluation of KAFIL EL-TORRES to begin. All reports from the evaluator must be reviewed by the full Board and Deputy Attorney General. A vote was taken and the motion unanimously passed.

8. INQUIRY EMAIL: JANUARY 11, 2017 FROM: DEZHI YANG

Does an Absorption Chiller Service business need a HVACR license?

On February 7, 2017, the Board discussed this matter and concluded in a motion made by Daniel G. Danko, Jr. and seconded by Domenic D. Demico, Jr. that "chillers" are within the Scope of Practice of the Master HVACR Contractor; therefore, the HVACR license is required for these tasks and for this business. A vote was taken and the motion unanimously passed.

9. INQUIRY EMAIL: DECEMBER 23, 2016 FROM: DAVE CASTNER

Is it appropriate to use Gypsum Board shaft walls as return duct in commercial buildings?

My concern is that by using this material it increases the chances of contaminating the HVAC system with bacteria, molds, and other unwanted hazards including vermin.

On February 7, 2017, the Board discussed this issue and noted that the International Mechanical Code for 2015 includes as section for "gypsum ducts." An agreement was reached whereby Member Thomas C. Pitcherello will investigate the code and return to the Board with his findings.

A vote was taken and the motion unanimously passed.

10. INQUIRY EMAIL: JANUARY 3, 2017 FROM: MICHAEL WILSON LICENSED MASTER PLUMBER NUMBER # 12615 LICENSED MASTER HVACR CONTRACTOR # 3552

Is it factual that as an HVACR contractor I have to give a one year warranty with every job I complete?

Is this actually a law? If so, where can I find the actual written statute that states this?

On February 7, 2017 the Board agreed in a motion made by Daniel G. Danko, Jr. and seconded by Paul J. Mitchell, that the existing New Jersey HVACR Regulations and Statutes do not contain any reference to a one year warranty– or any warranty– with respect to jobs completed by licensees for consumers. The licensee may consider researching other State or Federal regulations to rule out the possibility of other requirements. A vote was taken and the motion unanimously passed.

## 11. INQUIRY EMAIL: DECEMBER 28, 2016 FROM: LARRY PATERNO- SELF-EMPLOYED APPLIANCE REPAIR TECHNICIAN

A. Is an HVACR license required for the repair of refrigerators?

I have been in the technical field for thirty years and in the appliance repair business for the last fifteen years. I repair refrigerators, washers, dryers, microwaves and ovens. I do not work on sealed refrigerant systems.

B. If I go to school, acquire the relevant qualifications and pass the licensing test, do I have to work for another company for a period of time in order to be licensed? Or will my years of experience count for the hours needed in order to be accepted for licensing?

On February 7, 2017, the Board discussed this matter and concluded in a motion made by Paul J. Mitchell and seconded by Domenic D. Demico, Jr., as follows:

- A. Is an HVACR license required for the repair of refrigerators? Response: Yes
- B. With respect to qualifications for a Master HVACR License, the Board referred Mr. Paterno to existing New Jersey HVACR Statutes and Regulations, for the qualifications, via the below link to the HVACR Home Page:

# 12. INQUIRY - EMAIL: JANUARY 3, 2017 FROM: ALISON K. EVANS, ATTORNEY AT LAW

I would like to clarify whether cryogenic systems, used <u>outside</u> the scope of medical gas piping, fall within the definition of "hydronic piping" for purposes of N.J.A.C. 13:31-1.4(e)(4). According to this regulation, this installation, service and maintenance of gas and hydronic piping <u>may be performed by both licensed Master Plumbers and individuals who are not licensed Master Plumbers</u>.

### 12. INQUIRY - EMAIL: JANUARY 3, 2017 FROM: ALISON K. EVANS, ATTORNEY AT LAW

If the definition of "hydronic piping" for purposes of N.J.A.C. 13:31-1.4(e)(4) <u>includes</u> cryogenic piping systems, am I correct in saying that according to the language of this regulation, that an individual who <u>is not</u> a licensed Master Plumber may install, service and perform maintenance of such systems?

On February 7, 2017, the Board discussed this matter and concluded in a motion made by Daniel G. Danko, Jr. and seconded by Thomas C. Pitcherello, that existing regulations [N.J.A.C. 13:31-1.4(e)(4)] do require an amendment since the onset of the HVACR license, HVACR Statutes and Regulations. The task of hydronic piping remains within the scope of practice of the Master HVACR Contractor and the Licensed Master Plumber.

The Board anticipates an amendment will be handled by Charles Manning, Regulatory Analyst.

A vote was taken and the motion unanimously passed.

13. INQUIRY EMAIL: JANUARY 3, 2017 FROM: MIKE MEADE

If a propane company is installing temporary heat for a building under construction from a bank of 4100lbs tanks, does the contractor connecting the propane gas lines to the heater need an HVACR or a plumbing license?

On February 7, 2017, the Board discussed this inquiry and concluded in a motion made by Daniel G. Danko, Jr. and seconded by William C. Barham, that either the Master HVACR license or the Master Plumber's license is required for this task— additionally, a person certified by the Department of Community Affairs in propane, may also perform this task. A vote was taken and the motion unanimously passed.

#### 14. DISCUSSION HVACR APPLICATIONS BY RECIPROCITY EMAIL: NOVEMBER 22, 2016 FROM: CHARLES MANNING- REGULATORY ANALYST

On February 7, 2017, Board Members reported that they have each reviewed the qualifications and regulations of the following States, and subsequent to a discussion with DAG Donofrio and Regulatory Analyst, concluded in a motion made by Daniel G. Danko and seconded by Domenic D. Demico, Jr., that <u>none of the following states meet the qualifications</u> for reciprocity pursuant to existing New Jersey HVACR Statutes and Regulations, N.J.A.C. 13:32A-2.5 Reciprocity with other States:

Maryland Texas Ohio Florida Tennessee Alabama

Below states do not have State-wide licensing and therefore, do not meet reciprocity requirements:

Pennsylvania New York Illinois

The Board further agreed that each reciprocity application will be reviewed to determine if any of the applicants meet the qualifications for an HVACR license by examination. A vote was taken and the motion unanimously passed.

15. DISCUSSION BACKFLOW PREVENTERS - EMAIL: JANUARY 4, 2017 FROM: CHARLES MANNING- REGULATORY ANALYST

#### RECUSAL: MICHAEL MALONEY DID NOT PARTICIPATE IN THIS DISCUSSION.

On February 7, 2017, Charles Manning and DAG Donofrio were present for a discussion with Board Members concerning the scope of practice and task of installing backflow preventers.

Members agreed to delete "residential" and amend the regulation to include "non-testable devices" and in cases of "replacement only." A motion was made by Thomas C. Pitcherello and seconded by Kevin S. Clark. The motion passed. Paul Mitchell opposed the motion.

# 16. DISCUSSION EMAIL: JANUARY 6, 2017 FROM: FRANCIS WAY RE: REQUEST TO BE GRANDFATHERED BASED ON EXPERIENCE AND CERTIFICATIONS
