The Legalized Games of Chance Control Commission met on March 14, 2012, at the Division of Consumer of Affairs, located at 124 Halsey Street, 7rd Monmouth Room, Newark New Jersey. Present were Chairperson Marilou Halvorsen, Commissioners Edward Barrett, Christine Vanek, and Peter Curatolo. Also in attendance: Deputy Attorney General Nancy Miller, Assistant Counsel Nicole P. Crifo, Authorities Unit, Office of the Governor; Investigators Supervisor Martin Silva and Joseph Chessere; Head Clark Deborah Barnes, and supporting staff Farah Rodriguez and Margaret Kane.

The meeting was opened at 10:40 a.m. by Commissioner Halvorsen pursuant to provisions of the Open Public Meetings Act. N.J.S.A. 10:4-6 et seq.
