Pattie Lucarelli, RN, MSN, APNC, CPNP, Child Care Health Care Consultant Coordinator, Care Services of Monmouth County.

Ritamarie Giosa and Pattie Lucarelli reviewed their roles as Child Care Health Consultant Coordinators and discussed their concerns about medication administration to children in New Jersey Child Care Centers. The Committee received the presentation and noted that the issue of delegation of medication administration to unlicensed assistive personnel is under review by the Board of Nursing Regulation Committee.

The committee planning flow sheet was reviewed and revised.

The committee met on December 14, 2004 and January 25, 2005 to discuss the following issues:

The Flow Sheet

APN Rules:

George Hebert, Executive Director, gave a report on the APN Stakeholders Meeting presented by the American Nurses Association which included a discussion of goals and principles for a system of educating and certifying

Advanced Practice Nurses. The group emphasized the need for national consistency and standardization through a core curriculum for Nurse Practitioners, Clinical Nurse Specialists, Nurse Anesthetists, and Nurse Midwives. The standardized core curriculum could serve as the foundation for clinical practice specialties for Advanced Practice Nurses. The stakeholders expressed concern for consistency and standardization across boards of nursing for licensure regulations, accessibility of care and mobility of APN's.

The Committee continued to work on revisions and new proposals for Subchapter 7, including a discussion of APN categories of clinical specialty for practice. For the title of Advanced Practice Nurse, the Committee decided to draft a new rule that would recognize that the term "advanced practice nurse" includes nurse practitioners, clinical nurse specialists and certified registered nurse anesthetists. The Committee reviewed the proposed regulations for CRNA's including grandfathering of CRNA's as Advanced Practice Nurses and the implications for practice when the grandfathering period ends.

The Committee discussed APN certification renewal and the implications for practice when an APN certificate expires.

The Committee will continue to discuss the APN proposed regulation changes at the next available Committee Meeting.

Ms. Saravia informed the Board regarding the Petition for Certification to the Supreme Court for the CRNAs. There is a stay of the Board of Medical Examiners (BME) Regulations pending full decision by the Supreme Court. The BME filed for reconsideration of the stay. Ms. Saravia thanked the Board for their support.

Kathryn Jimate, Student from William Paterson College, requested clarification on Physical Therapy performed by a registered nurse.

Josephine Sienkiewicz, Director of Education and Clinical Practice of New Jersey Home Health Assembly, thanked George Hebert and Michelle Carroll for their assistance in clarifying the regulations for certification of Homemaker Home Health Aides who are Certified Nurse Aides

Point of Clarification: The regulations, N.J.A.C. 13:37-14.4 and 14.5, have not been amended. Certified Nurse Aides who have passed the Clinical Skills Checklist test for the Unlicensed Assistive Personnel Core Curriculum, completed the Home Care and Hospice Module, and meets the requirements of 76 hours, to include 60 hours of classroom instruction and 16 hours or clinical instruction in a skills laboratory or patient care setting, may be certified as a Homemaker Home Health Aide. Ms. Sienkiewicz requested a written confirmation from the Board of Nursing regarding this issue.

Neddie Serra, Bloomfield College, requested clarification on the New Education Regulations.
