V. MODALITIES COURSES APPROVAL

A. Request for modalities courses approval from Licensees

The Council reviewed letters and courses taken by the following licensees for approval:

The Council, upon motion made by Maryann E. Moran and seconded by Tiffany Charles, determined that a letter be sent to Ms. Lawrence advising her of the missing hours of training in light, heat and ultrasound as required by N.J.A.C. 13:44K-5.4; Use of physical agent modalities.

B. Request for approval of modalities courses by providers

Pursuant to <u>N.J.A.C</u>. 13:44K-5.4 Use of physical agent modalities, Council reviewed committees's recommendation regarding physical agent modalities courses submitted by:

1. Rehab Education, LLC March 20-21; 27-28, 2011

2. DUNAMIS Training, LLC May 21-22, 2011

The Council, upon the motion made by Maryann E. Moran and seconded by Tiffany Charles, voted to accept the recommendation of the committee and approved courses for modalities on the dates shown.

4. R.A.S HealthCare

The modalities training course submitted by R.A.S. HealthCare was reviewed by the Modalities's Committee and it was found not in compliance with the requirements pursuant to N.J.A.C. 13:44K-5.4, therefore not recommended for approval.

The Council, upon motion made by Mariann E. Moran and seconded by Aida Mendez-Boud voted that a letter be sent to R.A.S.HealtCare advising of the denial and also offering the company the opportunity to re-submit a course that will meet the regulatory requirements along with the curriculum vitae of the instructor (s).

5. ELITE Rehabilitation Solutions (Off Agenda)

The modalities training course submitted by ELITE Rehabilitation Solutions was reviewed by the Council. The course was to be offered in two different formats, online "blended" and "traditional" live, in person instruction. The curriculum vitae of the instructor was not submitted.

The Council, upon the motion made by Mariann E. Moran and seconded by Aida Mendez-Boud, asked that a letter be sent to ELITE Rehabilitation Services, indicating that the "blended" or online course does not meet the regulatory requirements. The "traditional" model to be offered, as long as provide live, in person instruction, will be acceptable if re-submitted along with the curriculum vitae for the instructor.
