# C. APPROVAL OF OPEN SESSION MINUTES OF JUNE 7, 2001 MEETING

On a motion by B. Mascari, seconded by A. Bradway, minutes were approved with corrections.

#### D. LEGISLATIVE REGULATORY

- 1. Fee decrease Darlene Kane, Budget Analyst for the Division made a presentation to the Committee on the excess surplus that currently exists. Miss Kane recommended to the committee to reduce the current fee schedule from \$350 to \$250 for licensed professional counselors and licensed rehabilitation counselors, and from \$260 to \$180 for licensed associate counselors. Committee requested Regulatory Analyst, D. Swenson to present to them for their review in September a change in the regulations to reflect this decrease.
- 2. Sexual Misconduct Regulations DAG, M. Bair and Regulatory Analyst, D. Swenson presented the committee with changes to the sexual misconduct regulations as recommended by the Division of Law.

On a motion by B. Mascari, seconded by J. Cohen, committee approved these regulations as amended.

### E. CORRESPONDENCE

- 1. Peggy Cummings Committee responded to Ms. Cummings that they would review all hours submitted by an appropriate supervisor. Committee also responded that the course she submitted is an acceptable course.
- 2. Carmella Friedman, L.R.C. Committee responded that she is not prohibited by her license to issue wage and loss projection reports. She was referred to the statutes and regulations for clarification on the scope of practice of an LRC.
- 3. Allison Misqulin Committee responded that she must submit background credentials and resume of her supervisor, in order to receive prior approval for this supervisor.
- 4. Gary Goldman Committee responded that New Jersey has been licensing professional counselors since 1986. The Executive Director, D. Gonzalez was instructed to send Dr. Goldman a copy of the Rules and Regulations
- 5. Ronald Rosenberg, P.H.D. Committee responsed to Dr. Rosenberg that they cannot render formal legal opinions. Committee referred Dr. Rosenberg to the Statutes and Regulations.

Board requested Executive Director, D. Gonzalez to handle both issues.
