Bergen County Prosecutor John Molinelli said John T. O'Brien, 48, wronged members of the Colony co-op when in September of 2012 he was hired to purchase copper piping and other related materials to be used in a riser replacement project. O'Brien agreed to purchase the items and have it locked in a separate area, Molinelli said. But after comparing purchase orders as to what was in the room, it was discovered that O'Brien never purchased \$648,337 of the total \$1,437,733 of materials the contract called for, the prosecutor said.
