1. REQUEST FOR CONTINUANCE OF BUSINESS (COB)

GEORGE PARKER, LMP # 6094 ~ **DECEASED 3/26/03**  
T/A G. PARKER PLUMBING, HEATING AND AIR-CONDITIONING  
COB REQUESTED BY EDWARD R. JONES, II, LMP # 5869

Licensee Edward R. Jones, II, contacted the Board Office through his correspondence dated May 25, 2003, to advise that his uncle passed away on March 26, 2003. He advised that his uncle's son, Donald G. Parker, is a candidate for the Master Plumber's examination, and is scheduled to test on August 5, 2003.

Mr. Jones requests permission of the Board to serve as the supervising bona fide representative for G. Parker Plumbing, Heating, and Air-Conditioning, until the candidate becomes licensed. The Board is requested to review Mr. Jones' correspondence and consider that the New Jersey Plumbing Statutes and Regulations will permit one six-month COB for this business.

2. ANTHONY M. LUISE ~ EXPIRED  
FORMER LICENSED MASTER PLUMBER # 6175  
REQUEST FOR REINSTATEMENT  
*Renewed on 8/15/85, with \$100 for the 1985-1987 biennial*  
*Did not renew for 1987-1989 or subsequent renewals*

Mr. Luise directs a letter to the Board dated April 21, 2003, requesting the reinstatement of his Master Plumber's license.

On August 15, 1985, Mr. Luise paid the sum of \$100 for his license renewal during the 1985-1987 biennial; however, he neglected to pay for any subsequent biennial renewals.

A letter dated May 29, 2003, was prepared by DAG Donofrio and issued to Attorney James H. Gorman, Esquire, outlining the findings of the Board at their recent meeting of May 22, 2003. Mr. Gorman had been present with Richard Marra on May 22, 2003, to submit his client's request for approval as a candidate for the Master Plumber's examination.

Subsequent to testimony provided on May 22, 2003, Board Members concluded that Richard Marra does not meet the qualifications for a candidate under the existing New Jersey Plumbing Statutes and Regulations. The Board noted that Mr. Marra maintains the option of hiring a bona fide representative to allow Marra Construction to provide plumbing services. The request for a COB was denied on April 24, 2003.

IN THE MATTER OF THE SUSPENSION OF REVOCATION OF THE LICENSE OF **MICHAEL J. MESSICK,**  
**LMP # 8963,** TO PRACTICE AS A PLUMBER IN THE STATE OF NEW JERSEY

Respondent is reprimanded for having engaged in professional misconduct in that he failed to complete a job. A \$250 penalty is assessed for violation of N.J.S.A. 45:1-21(h) for the licensee's failure to display his plumbing license number on work order/ invoice # 21254 and work order/invoice # 21661, in violation of N.J.A.C. 13:32-3.1, Identification of licensees.

Licensee Messick accepts the terms of said order and signs same on May 21, 2003, enclosing a \$250.00 check.

Respondent applied to have the State Board of Examiners of Master Plumbers approve his taking the licensing examination for Master Plumbers.
