VII. CORRESPONDENCE

A. Letter from Alexia Peratikos-Kiritsis, Psy.D., TP#123-024

The Board reviewed Dr. Peratikos-Kiritsis' correspondence regarding the extension of her permit. Dr. Peratikos-Kiritsis will be advised that her temporary permit will now expire on February 23, 2016. *Upon motion by Dr. Brickfield, seconded by Dr. Wolf-Mehlman, the Board voted to extend Dr. Peratikos-Kirtsis's permit for one year. D. Letter from Jane Selzer of the New Jersey Psychological Association

The Board reviewed correspondence from Jane Selzer of the New Jersey Psychological Association regarding the jurisprudence webinar. Ms. Selzer agreed to change the fee to be consistent with the fees charged to all applicants. Executive Director recommended that the Board require a notarized affidavit as verification for completion of the webinar for all

licensees who are applying for reciprocity. Upon motion by Dr. Wolf-Mehlman, seconded by Dr. Peckman, the Board voted to proceed with implementation of the jurisprudence webinar. Voting in favor: all.

E. Supervisory Form for Elana Rosencrantz, Psy.D

The Board reviewed Dr. Elana Rosencrantz' supervisory form which stated that her supervisor, Laura Brown, Ph.D., had a disciplinary issue in the past in another state and does not currently have the records at hand. *Upon motion by Dr. Wolf-Mehlman, seconded by Dr. Peckman, the Board voted to have Dr. Brown obtain records of her disciplinary action from the Washington psychology board and forward a copy to this Board. Voting in favor: all.*

F. Response from Alexander Mondrow, Psy.D., TP #113-017

The Board reviewed a letter from Dr. Mondrow requesting that the Board accept training hours earned prior to his permit. *Upon motion by Dr. Wolf-Mehlman, seconded by Dr. Peckman, the Board voted not to accept Dr. Mondrow's supervised hours before his permit was issued pursuant to N.J.A.C 13:42-3.2. Voting in favor of the motion: all.*

VIII. REPORT ON PERMIT CONFERENCES

A. Evan Jaffe, Psy.D./Gary Borer, Ph.D., supervisor

Dr. Jaffe was seen by a committee of the Board to discuss his plan for taking the E.P.P.P. examination. *Upon motion by Dr. Brickfield, seconded by Dr. Wolf-Mehlman, the Board voted to extend Dr. Jaffee's permit by one year with the following changes in case load: No more than five hours of direct contact with clients, contingent on his taking of the exam by October 31, 2015. Voting in favor: all.*

X. REVIEW OF LEGISLATION

A. Assembly, No. 2892 - Allows certain Psychologists to prescribe medicine. *The Board accepted this as informational.*

B. Assembly, No. 4309 - Transfers Division of Mental Health Advocacy to the Department of Human Services. *The Board accepted this as informational.*

C. Autumn Joy Stillbirth Research and Dignity Act - The Board was addressed by representatives from the Department of Health Scott Owens, HSS and Gene Brenycz Regulatory Officer. They were looking for guidance from the Board on how or when a

psychologist should offer counseling in a hospital setting.

XI. PUBLIC COMMENT

A. Dennis Finger, Ed.D., New Jersey Psychological Association (NJPA)

Dr. Finger asked the Board to clarify how long of a wait time there is to sit for the jurisprudence exam. The Executive Director responded that there is currently not a long wait, only that at the moment applicants register for the exam and then drop out at the last minute, causing wasted spaces which slows the process down for everyone. The Board agreed that going forward the examination fee should be paid in order to confirm a seat. The candidates will also be informed that the fee will be forfeited in the case of late cancellations and that they will need to be reassigned and pay the exam fee again.
