The Board will also advise Ms. Poston that the Board does not endorse any specific products and they cannot state that he board has endorsed these products in any advertising or correspondence done to New Jersey licensed physical therapists.

The Board reviewed an inquiry from Eric Goldberg, PT who inquired as to whether physical therapists could accept referrals from Advanced Practice Nurse since direct access has been approved. The Board would like to advise Mr. Goldberg that with direct access in place a referral is no longer required. A referral is required in certain circumstances for reimbursement. Mr. Goldberg may want to inquire as to what the third party payor policies are in terms of reimbursement and the requirement of a referral.

# F. INQUIRY ON RATIO OF PHYSICAL THERAPIST TO PHYSICAL THERAPIST ASSISTANTS

The Board reviewed an inquiry as to the number of physical therapist that are needed to supervise physical therapist assistants. The Board would like to state that there is one physical therapist allowed to supervise two physical therapist assistants, according to N.J.A.C. 13:39A-7.1 (b).
