#### T.O.E.F.L. WAIVERS:

#### 1. ALFONSO RODRIGUEZ

Alfonso Rodriguez appeared before the Board to request a waiver of the TOEFL requirement for foreign-educated individuals applying for licensure. Mr. Rodriguez is applying for licensure as a physical therapist by endorsement in the State of New Jersey. He was educated in the Philippines and received his professional as well as undergraduate education in the English language. Mr. Rodriguez is licensed in Michigan.

Upon a motion made by Gary Savander and seconded by Barbara Behrens, the Board voted to grant Mr. Rodriguez a waiver of the TOEFL requirement based upon the fact that his professional as well as his undergraduate education was conducted in the English language and he demonstrated proficiency. The motion carried by a unanimous vote.

#### 1. MARGARITA DUNGAN

Margarita Dungan appeared before the Board to request a waiver of the TOEFL requirement for foreign-educated individuals applying for licensure. Ms. Dungan is applying for licensure as a physical therapist by endorsement in the State of New Jersey. She was educated in the Philippines and received her professional as well as undergraduate education in the English language. Ms. Dungan is licensed in New York.

Upon a motion made by Gary Savander and seconded by Barbara Behrens, the Board voted to grant Ms. Dungan a waiver of the TOEFL requirement based upon the fact that her professional as well as her undergraduate education was conducted in the English language and she demonstrated proficiency. #### I. NEW BUSINESS:

# A. ELECTIONS FOR THE BOARD OF PHYSICAL THERAPY EXAMINERS 2006

A motion was made by Gary Savander and by Jeffrey Erickson to close nominations. The Board members voted by paper ballot and the result was Karen Wilk-4 and Mary Browne-5. As a result of the vote, Mary Browne is the Vice Chairperson of the New Jersey State Board of Physical Therapy Examiners for 2006.

A motion was made by Barry Inglett and seconded by Barbara Behrens to nominate Karen Wilk for Secretary of the Board. A call for further nominations were made and there were none.

A motion was made by Mary Browne and seconded by Gary Savander to close nominations and elect Karen Wilk as Secretary by acclamation. The vote of the Board was unanimous.

# B. INQUIRY FROM BJ GEROW, PT RE: MEDICATION ORDERS

The Board reviewed correspondence from BJ Gerow, PT. The Board would like to advise Ms. Gerow that physical therapists can record medication orders in a patient record but cannot take medication orders. A physical therapist can do wound care and report findings or suggest wound care changes to the medical doctor. The physical therapist can also do admissions to home care.

## C. INQUIRY FROM ROY F. JACKSON, DC RE: ORTHOTICS

The Board reviewed an inquiry from Roy F. Jackson, DC. Dr. Jackson inquired as to whether it was within the scope of practice for a physical therapist to fit a patient for orthotics to treat biomechanical abnormalities of the feet and if so, can a physical therapist bill for the orthotics. The Board will advise Dr. Jackson to review N.J.S.A 45:12B-18 of the Orthotics and Prosthetics Statute. If he has any additional questions he should contact the Orthotics and Prosthetics Board of Examiners.
