Announcement of Quorum

IV. EXECUTIVE DIRECTOR'S REPORT

Executive Director J. Michael Walker introduced the Board's new administrative staff member, Courtney Turner.

He also informed the Board that the revision to the regulations are scheduled for publication in September and that there will be a 60 day public comment period. The Telehealth Bill has been signed into law and the mental health boards are working on regulations.

V. PUBLIC COMMENT

Ms. Weston informed the Board that she has receive calls regarding the new Telehealth Bill. She will inform the licensees that the Board is currently working to draft regulations. She will contact Executive Director Walker or Deputy Attorney General Krugman should she receive complicated questions.

Ms. Weston asked if there was any new rules/regulations coming that would change the track of applicants for the LCSW license. Ms. Weston was informed that MAT program students must have 12 graduate "clinical" credits from an accredited school to be eligible for licensure.

Ms. Weston also posed a question regarding MAT (management/administrative track) students. Ms. Weston was informed that the coursework that the students receive will not satisfy the clinical course requirements for LCSW licensure. If new rules are adopted that change the licensure requirement, the colleges will receive notification.
