#### II. REVIEW OF MINUTES

1. October 29, 2024 Public Minutes

On a motion by Dr. Wilson, seconded by Ms. Browne, the Board approved the public minutes. Voting in favor: All.

## III. EXECUTIVE DIRECTOR'S REPORT

Mr. Schulberg reported that there were 372 active licensees in the state. This included 372 licensed behavior analysts and 0 licensed assistant behavior analysts.

There were 644 pending applications for licensed behavior analysts and 5 pending applications for licensed assistant behavior analysts.

## IV. <u>CORRESPONDENCE</u>

1. **Kelly Goldberg, MS Ed, BCBA** – Questions related to students practice of behavior analysis

The Board discussed Ms. Goldberg's correspondence related to student practice of behavior analysis and whether they are permitted to complete a FBA interview without a supervisor in the room if the supervisor signs off on all notes. Per N.J.A.C. 13:42b-1.1, a licensee may delegate services to paraprofessional technicians and the Board has no authority over student practice because they are exempt as long as they are being supervised and meet the regulation. Therefore, it would be up to the program to decide. The Board noted that graduated students would not be permitted to practice as they'd no longer meet the student exemption and any practice would be considered unlicensed.

On a motion by Dr. Wilson, seconded by Mr. Paone, the Board voted to provide Ms. Goldberg the regulations, refer her to <u>N.J.A.C.</u> 13:42B-1.1, and provide the above information. Voting in favor: All.

2. **Megan Pfau, MA** – Questions on informed consent and advertisement

The Board discussed Ms. Pfau's correspondence on behalf of the Children's Specialized Hospital regarding informed consent and advertisement, noting that the hospital should seek legal counsel if desired to answer her questions pertaining to N.J.A.C. 13:42B-4.6 and N.J.A.C. 13:42B-6.3. Ms. Pfau also requested clarification on the licensure process timeline and whether there was a due date to be licensed by in which the Board instructed administrative staff to provide the standard answers.

On a motion by Ms. Toole, seconded by Dr. Wilson, the Board voted to inform Ms. Pfau that the organization should seek counsel if desired to answer her questions pertaining to <u>N.J.A.C.</u> 13:42B-4.6 and to <u>N.J.A.C.</u> 13:42B-6.3 . Voting in favor: All.

On a motion by Mr. Paone, seconded by Dr. Wilson, the Board voted to have administrative staff provide Ms. Pfau the standard answers regarding licensure timeline and whether there's a due date for licensure. Voting in favor: All.
