1. Jurisprudence questions

3. Board communication with the Department of Education

Regulatory Analyst Manning noted that internal approval was provided to meet with the Department of Education. Executive Director Schulberg will set up the meeting to discuss the intersection of regulations.

On a motion by Dr. Wilson, seconded by Mr. Blough, the Board approved the meeting to be set up with the Department of Education. Voting in favor: All.
