II. REVIEW OF MINUTES

1. April 23, 2024 Public Minutes

On a motion by Ms. Toole, seconded by Mr. Paone, the Board approved the public minutes. Voting in favor: All.

III. OLD BUSINESS

1. Review of electronic demo applications

The Board subcommittee provided the Board with proposed edits to the draft applications. The department will incorporate the agreed upon edits and the Board will then review the next draft before its finalized.

2. <u>Board communication with the Department of Education</u>

The Board will follow-up with the DOE to request an update on the status of the draft DOE guidance.

3. Criminal history background check for applicants

Dr. Buchanan expressed her recommendation that the Board consider a brief postponement of opening the application to the public to allow time for the Legislature and Governor to advance legislation that would provide the statutory authority for the Board to require a criminal history background check (CHBC) for its applicants. She cited the Board's fundamental duty to "protect the health, safety, and welfare of the people of New Jersey" as paramount. She continued that the brief delay would afford the benefit of CHBC for all applicants, not just the subset who applied after the law would be enacted. She also expressed concern regarding the public messaging that some state licensed behavior analysts had background checks, and others did not. Dr. Buchanan requested the Division's and Board's consideration of a two-month delay and agreed that, should the bill not advance by June 30, 2024, that the Board proceed with the application process without further delay.

IV. NEW BUSINESS

1. Federal anti-trust protections

Regulatory Analyst Manning provided guidance on Board indemnification and anti-trust protections.

2. QABA Credentialing Board request

The Board discussed QABA's request to be recognized as a credential for licensure in New Jersey and noted that QABA is a for-profit organization and therefore doesn't meet the statutory requirement as per N.J.S.A. 45:8B-99 and 100.

On a motion by Ms. Toole, seconded by Mr. Paone, the Board voted to deny QABA's request and provide a response with the above information. Voting in favor: All.
