PROPOSED AMENDMENT N.J.A.C. 5:23-2.7

7. Mr. Schooley requested that the Board review proposed amendment N.J.A.C. 5:23-2.7.

The Department of Community Affairs is proposing to redefine "ordinary maintenance" to include the installation of communications wiring within a one-unit dwelling, or within an individual dwelling unit in a multi-unit building, provided that the rearrangement does not involve the penetration of a fire-rated assembly and is not located in a hazardous location as defined in Chapter 5 of the electrical subcode.
