N.J.A.C. 13:31-1.7 CONTINUING EDUCATION

6. Board to review a draft of N.J.A.C. 13:31-1.7 Continuing Education requirements which would allow a licensee to earn a maximum of four credits per triennial registration period in interactive, computer-based courses that have been approved by the Board.

Language was also drafted to allow a licensee to obtain continuing education credit, consistent with the requirements of N.J.A.C. 13:31-1.7, for completing continuing education courses concerning alarms and/or electronic security systems that have been approved by the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee, pursuant to N.J.A.C. 13:31A1-.12 provided the licensee obtains a certificate of completion from the course sponsor.
