N.J.A.C. 13:31-5.1 REGISTRATION AS QUALIFIED JOURNEYMAN ELECTRICIAN

15. Suzanne Borek, Code Specialist, Division of Codes and Standards, sent an e-mail stating that N.J.S.A. 45:5A-18(l) is not included in N.J.A.C. 13:31-5.1(a).

Therefore, the Board should discuss amending the regulation to include the following language in N.J.A.C. 13:31-5.1 Registration as Qualified Journeyman Electrician:

(a) A person shall register as a qualified journeyman electrician in order to engage in activities set for in N.J.S.A. 45:5A-18(k and l), and if the person is not a licensee, in order to supervise the performance of electrical work pursuant to N.J.A.C. 13:31-3.4.
