DAVID J. HINTON, LICENSE #11267

1. Check in the amount of \$200.00 received from David J. Hinton, License #11267, t/a Hinton and Son Electric, LLC, as the fourth installment of a civil penalty in the amount of \$2,000.00 as reflected in the Final Order of Discipline filed October 5, 2016, ordering Mr. Hinton to pay a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:1-21 (e). Payments began on November 29, 2016 and the balance due is \$1,200.00.

EDWARD JOHNSON, LICENSE#7469 (REVOKED)

2. Payment in the amount of \$1,000.00 received on February 16, 2017, from Edward Johnson, License #7469 (Revoked), as the seventh installment of a civil penalty in the amount of \$30,000.00 for violation of N.J.S.A. 45:5A-9; N.J.A.C. 13:31-1.5(e); and N.J.S.A. 45:1-21(e). Mr. Simmonds has failed to respond to the Provisional Order of Discipline filed February 8, 2017, ordering that Mr. Simmonds is provisionally reprimanded for violation of N.J.S.A. 45:1-21(e); License and Business Permit #14229 is provisionally suspended until such time as he appears before the Board to discuss the complaint; provides W-2 income tax forms from 2007 to 2013; and pays the civil penalty in the amount of \$2,500.00 plus costs in the amount of \$100.00.

COMMUNICATIONS

ASSEMBLY BILL NO. 4754

6. Board to review Assembly Bill No. 4754 which provides that no provision of the State Heating, Ventilating, Air Conditioning and Refrigeration Contracting Licensing Law will be construed to prevent licensed electrical contractors from engaging in the installation, maintenance, and repair of gas piping while installing or repairing electric generators. Current law prohibits licensed electrical contractors from performing natural gas piping work, and permits only licensed master HVACR contractors and licensed master plumbers to perform natural gas piping work.

ANTHONY VIGNALI, LICENSE #14343

7. Response dated March 6, 2017, received from Anthony Vignali, License #14343 to the Provisional Order of Discipline filed February 8, 2017, ordering upon service of the filed Final Order of Discipline, Mr. Vignali's License and Business Permit #14343 is suspended for five years; assessed a civil penalty in the amount of \$10,000.00 for violation of N.J.S.A. 45:5A-9 in that he qualified more than one person for a business permit; permitted an unlicensed person to perform an act for which a license is required; and signed and sealed electrical permits for John Sahlberg and Sahlberg Electric, Unlicensed.
