## ASSEMBLY BILL NO. 4330

7. ### RAFAEL PEREZ, UNLICENSED

13. Mr. Perez has failed to respond to a Uniform Penalty Letter offering him the opportunity to settle the matter by paying a civil penalty in the amount of \$1,500.00 for violation of N.J.S.A. 45:5A-9; restitution in the amount of \$182.50; and sign an agreement to cease and desist from engaging in the business of electrical contracting in the State of New Jersey until such time as he become licensed.

#### FREDERICK J. MAGEE, LICENSE #14622

14. Mr. Magee has failed to respond to the Provisional Order of Discipline filed January 7, 2015, ordering he is provisionally reprimanded for his violation of N.J.S.A. 45:1-21(h) and N.J.S.A. 45:1-21(e); pay a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:1-21(e); pay restitution to the consumer in the amount of \$3,309.50; and License and Business Permit #14622 shall provisionally remain suspended until such time as Mr. Magee satisfies restitution and penalties assessed.
