The Board reviewed an Application to Reinstate an Expired Electrical Contractors License received from Wayne P. DeAngelo, License #11328.

Office files reflect that License #11328 expired on March 31, 2009.

Office files also reflect Mr. DeAngelo was never issued a business permit.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Anthony L. Anzelone, and passed to reinstate Mr. DeAngelo's License #11328, as he demonstrated to the Board's satisfaction that he meets the requirements for reinstatement.

The Board reviewed an Application to Reactivate an Inactive Electrical Contractors License received from James Calderone, License #16437.

Office files reflect that License #16437 was placed in inactive status on June 10, 2015.

Office files reflect Business Permit #16437, t/a Calco Electric Corp., expired on March 31, 2012. Office files reflect that Mr. Calderone has not returned the pressure seal issued to Calco Electric Corp.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino A. Pasqualone, and unanimously passed, that this matter be discussed in Executive Session.

July 17, 2024

The Board reviewed an Application for Continuing Education Course/Seminar received from Lois D' Apuzzo Hammer, The Institute for Continuing Education, requesting approval for one (1) new instructor to teach one (1) updated course.

Motion made by Mr. Gino A. Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve one (1) new instructor to teach one (1) new course.

The Board reviewed an Application for Continuing Education Course/Seminar received from Christine Higgins, NJ Electronic Life Safety Association, requesting approval for one (1) approved instructor to teach seven (7) new courses.

Motion made by Mr. Gino A. Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve one (1) instructor to teach seven (7) new courses.

The Board reviewed a letter dated June 1, 2024 received from Bryan Sullivan requesting a second six-month continuance of business under Permit #4403 according to N.J.S.A. 45:5A-14. The licensee, Edward Sullivan, died on December 25, 2023. The Board approved Bryan Sullivan, to qualify the business.

The extension granted to Edward Sullivan Electrical Contractor expired on June 25, 2024.

Motion made by Mr. Gino A. Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, that Edward Sullivan Electrical Contractor be granted a second and final continuance of business under permit #4403 which will expire on December 25, 2024.

Mr. Sullivan will be advised that this is the final extension granted to Edward Sullivan Electrical Contractor. Therefore, if necessary, he should arrange with a licensed electrical contractor, with a current business permit, to complete any unfinished jobs after the extension has expired.

July 17, 2024

Executive Director, Ms. Philameana L. Tucker announced to the Board that the Electrical Board Meeting scheduled for August 14, 2024 has been canceled.
