947th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) JANUARY 8, 2020

Board meeting of January 8, 2020, was called to order at 9:00 A.M. The following members were present:

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was Christopher Lombardo; John Morra; Praveen Wadhwa.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve the Minutes of the 945th Open Session Business Meeting held November 13, 2019.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve eight (8) Initial Licenses which will expire on March 31, 2021.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve seven (7) Initial Business Permits which will expire on March 31, 2021.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve three (3) of five (5) Initial Business Permits Previously Expired effective January 8, 2020 to March 31, 2021. (#1 and #4 are being held in abeyance pending further review.)

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve one (1) of the two (2) Change in Business Permits effective January 8, 2020 to March 31, 2021. (#2 is being held in abeyance pending further review).

Check in the amount of \$300.00 received from James L. Morecraft, License #16513, t/a James Morecraft Electrical Contractor, as the second installment of a civil penalty in the amount of \$3,000.00 for violation of $\underline{\text{N.J.A.C.}}$ 13:31-3.3(c) (1). Payments started October 29, 2019 and the balance due is \$2,550.00.

The Board accepted the payment.

Two checks in the amount of \$167.00 each received from John Hartnett, License #15973, as the twelfth and thirteenth installment of a civil penalty in the amount of \$4,000.00 for violation of $\underline{\text{N.J.A.C}}$. 13:31-3.3 (c) (1). Payments began November 27, 2018 and the balance due is \$1,829.00.

The Board accepted the payment.

Check in the amount of \$50.00 received from George Isabella, License #14732, t/a George Isabella Electrical Contractor, as the eighteenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments began July 27, 2018 and the balance due is \$1,500.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Robert B. Bell, License #12246, t/a Robert B. Bell Electrical Contractor, as the first and final payment of a civil penalty in the amount of \$500.00 for violation of N.J.A.C. 13:31-3.2 (c).

The Board accepted the payment.

Check in the amount of \$2,500.00 received from Sergey Libizov, License #16770, t/a Sergey Electric, as the first and final payment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9(a).

The Board accepted the payment.

Check in the amount of \$200.00 received from Dennis Arcamone, License #13834, as the sixth installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments started March 15, 2019 and the balance due is \$1,400.00.

The Board accepted the payment.

Check in the amount of \$300.00 received from Richard K. Cotterell, License #12030, as the fifth installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments started August 22, 2017 and the balance due is \$1,600.00.

The Board accepted the payment.

The Board reviewed an application to Reinstate an Expired Electrical Contractors License received from David P. Smith, License #17500.

Office files reflect Mr. Smith's License and Business Permit #17500 expired on March 31, 2018.

Motion made by Mr. Anthony Anzelone and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

After a brief discussion in Executive Closed Session, the Board returned to Public Session and made the following motion.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to reinstate Mr. Smith's License #17500 as he has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement.

Letter received December 16, 2019, from Erich Jaeckle requesting a six-month continuance of business under Permit #11548 according to N.J.S.A. 45:5A-14. The licensee, Reiner E. Jaeckle, died on August 25, 2019.

Erich Jaeckle stated that he has been in charge of field operations and installation compliance and is an IBEW journeyman wireman.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Gino Pasqualone, and unanimously passed, that the firm of Metro Tek Electrical Services Company be granted a six-month continuance of business under permit #11548. The Board approves Erich Jaeckle to qualify the business for the six-month period.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Victor Lynch, Bergen County Technical Schools - Adult & Continuing Education, requesting approval to teach new courses and new instructors.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, that Mr. Lynch's request be held in abeyance. A letter will be sent to Mr. Lynch asking him if he is requesting approval of two seventy-eight hour courses or each module. Mr. Lynch will be advised if he wishes to teach all 78 hours, licensees must attend all 78 hours in order to receive credit towards their continuing education hours.

Mrs. Tucker stated that she received a e-mail from Harold Herman asking whether or not an electrical contractors license is required to install or repair appliances.

The Board directed that a letter be sent to Mr. Herman advising a license and business is not required to repair an appliance as long as that appliance has a manual disconnect.

However, any work on the branch wiring must be performed by a licensed electrical contractor with a business permit.

The Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Seventeen (17) applications were approved.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
