Due to the current state of emergency, the February 10, 2021 meeting of the Board of Examiners of Electrical Contractors was not held at 124 Halsey Street, but remotely. The Board saluted the Flag.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (13) Initial Licenses which will expire on March 31, 2024.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (13) Initial Business Permits which will expire on March 31, 2024.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (6) of the (7) Initial Business Permits Previously Expired effective February 10, 2021 to March 31, 2024. (#5 is being held in abeyance pending further review).

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve the Minutes of the 949th Open Session Business Meeting held July 30, 2020.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve the Minutes of the 950th Open Session Business Meeting held September 9, 2020.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve the Minutes of the 951st Open Session Business Meeting held October 14, 2020.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve the Minutes of the 952nd Open Session Business Meeting held November 11, 2020.

Check in the amount of \$150.00 received from Philip J. DeNivo, License #15902, as the seventh installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.A.C. 13:31-3.3(c)(1). Payments began March 27, 2020 and the balance due is \$1,800.00.

The Board accepted the payment.

Checks in the amount of \$150.00 received from Christopher Meyers, License #13140, as the third and fourth installment of a civil penalty in the amount of \$6,000.00 for violation of N.J.A.C. 13:31-3.3(c)(1). The balance due is \$5,400.00.

The Board accepted the payment.

Check in the amount of \$150.00 received from John A. Schipani, License #14228, t/a John A. Schipani Electrical Contractor, as the seventh installment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:5A-9(a). Payments began February 20, 2020 and the balance due is \$800.00.

The Board accepted the payment.

Checks in the amount of \$50.00 received from George Isabella, License #14732, t/a George Isabella Electrical Contractor, as the twenty-ninth and thirtieth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:31-3.3(c) (1). Payments began July 27, 2018 and the balance due is \$900.00.

The Board accepted the payment.

Postal Money Order in the amount of \$450.00 received from Robert A. Gramlich, License #12898, t/a Robert A. Gramlich Electric, as the third, fourth and fifth installment of a civil penalty in the amount of \$6,000.00 for violation of N.J.A.C. 13:31-3.3(c). Payments started January 9, 2020 and the balance due is \$3,900.00.

The Board accepted the payment.

Check in the amount of \$2,000.00 received from Brian W. Anacker, License #17288, as the first and final payment of a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:31-3.3 9(c) (1).

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Bruce M. Rockwell requesting approval to teach new courses and an instructor.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve ten (10) new courses and an instructor.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Briana Gdanitz, Warshauer Electric Supply, requesting approval to teach new courses and new instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that a letter be sent to Ms. Gdanitz requesting that she resubmit her request to teach the seven new courses. The course entitled "Electric Heat for Residential and Commercial Sales 2" does not meet the criteria of continuing education as a portion of the course deals with sales. Additionally, the courses submitted appear to be product specific.

Mr. Constantinos Papademas recused himself from the following discussion and motion, as he is the sponsor/instructor for the courses being submitted.

Application for Continuing Education Course/Seminar approval received from Constantinos Papademas requesting approval to teach new courses and an instructor.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (38) new courses and an instructor.

Application for Continuing Education Course/Seminar approval received from Monica Margaritis, National Electrical Contractors Association, requesting approval to teach new courses and new instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (6) new courses and new instructors.

Philameana L. Tucker advised the Board that PSI is no longer testing on the 2017 Code. The representative for PSI has advised that they have been unable to purchase the 2020 code books and would like to put the test on hold. However, there is already a delay in testing as only 25% are allowed to take the test on any given day.

Mrs. Tucker stated that she has had concerns raised by candidates that they have already studied the 2020 code, but the test may still be on the 2017 code.

Mrs. Tucker further stated that she has reached out to Francine Widrich to ask how we should handle this situation.

Mr. Papademas stated he had been advised that some testing sites are using the 2017 Code Book and some the 2020 Code Book.

The Board briefly discussed the sunset of the Board's regulations at N.J.A.C. 13:31-1 et seq. that will expire on March 16, 2022.

Anna Bennett, Regulatory Analyst, stated that the board's rules are set to expire on March 16, 2022. Ms. Bennett suggested that the Board begin to review its rules as this will afford the board members an opportunity to consider whether or not any changes need to be made.

Mr. Schooley stated that he will appoint a subcommittee to review the rules and regulations. The subcommittee will then discuss the proposed changes with the full board.

The Board discussed the proposed amendments to the continuing education proposal regarding distance learning.

Ms. Bennett stated she wanted to understand how the OSHA course is conducted; it is an online course, is it instructor led, etc.

Ms. Bennett also stated the Board proposed to limit the amount of non-live courses to eight hours per renewal at two hours in any given day.

Mr. Flaherty stated OSHA allows a licensee to take two hours one day and two hours another day which would be acceptable to the Board. Mr. Flaherty also stated that the OSHA course includes a test component and in order to complete each component, the licensee must pass a test. Mr. Flaherty further stated that the OSHA course is generally not an instructor led course.

Ms. Bennett stated she will include language in the proposal which reflects that licensees may receive credit for attending an OSHA approved on-line safety course.

The Board also discussed continuing education credits relating to the installation of gas piping regarding the installation or repair of an electric generator.

Mr. Scooley stated if licensees are required to take a course on gas piping, the Board will grant no more than two credit hours toward the license renewal.

This matter will again be discussed at the March 10, 2021 meeting.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.

Meeting adjourned at 2:00 P.M.
