

938th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - MARCH 13, 2019

The Board saluted the Flag.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (13) Initial Licenses which will expire on March 31, 2021.

March 13, 2019

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (9) Initial Business Permits which will expire on March 31, 2021.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve the Minutes of the 937th Open Session Business Meeting held February 13, 2019.

Payment in the amount of \$439.50 received on January 29, 2019, from Carl J. Swenson, License #4309, S Swenson & Son, Inc., as the eleventh installment of a civil penalty, costs, attorneys fees and interest in the amount of \$4,974.56. Payments began on December 16, 2002 and the balance due is \$1,607.39.

The Board accepted the payment.

The Board accepted the payment.

The Board briefly discussed the idea of allowing on-line continuing education courses.

Mr. Flaherty stated that facial recognition soft ware would ensure that the licensee is taking the course. Mr. Flaherty also stated that the soft ware shuts down if the licensee walks away from the computer; or if someone else sits in front of the computer, the program will automatically start again.

This matter will again be discussed at the June 12, 2019 meeting.

The Board reviewed the application for Reinstatement of a License received from David B. Berardi, License #12016 (Expired).

March 13, 2019

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, to reactivate Mr. Berardi's License #12016 as he has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement.

The Board reviewed an application to Reactivate an Inactive Electrical Contractors License received from Jaime Abramo, License #11917 (Inactive).

Office files reflect Mr. Abramo chose Inactive status for his License #11917 on May 6, 2009.

Office files also reflect Business Permit #11917 expired on March 31, 1997.

Pressure seal issued to Jaime Abramo Electrical Contractor returned to the Board office on February 14, 2019.

Mr. Abramo provided copies of continuing education course certificates for the renewal periods of 2003; 2006; 2009; 2012; 2015 and 2018.

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

The Board reviewed an application to Reactivate an Inactive Electrical Contractors License received from Curtis E. Trotman, License #16408 (Inactive).

Office files also reflect that Mr. Trotman never held a business permit.

After discussion in Closed Session, the Board returned to Open Session.

March 13, 2019

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Theodore Kitchmire, Suzanne Childers (Sponsor #072), requesting approval of new courses and instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that Mr. Kitchmire's request be held in abeyance. The Board requested that Mr. Kitchmire advise if he is requesting approval to teach the 2014 changes or the 2017 changes. Mr. Kitchmire will also be requested to provide an outline for the one hour course and an outline for the two hour course. Upon receipt of same, Mr. Kitchmire's request will be approved.

Mr. Schooley advised the Board that he was invited to attend a meeting with the Governor's counsel to discuss the installation of gas piping.


Mrs. Tucker stated that she has nothing to report to the Board.
