The Board reviewed an Application to Reinstate Expired Electrical Contractors License #18050 received from Richard Agnello.

Office files reflect that Mr. Agnello's License #18050 expired on March 31, 2021.

Office files also reflect that Mr. Agnello chose Inactive status for Business Permit #18050 on January 24, 2017.

Office files do not reflect that the pressure seal issued to Agnello Electrical Contracting, LLC has been returned to the Board office.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, that this matter be discussed in Executive Session.

The Board reviewed an Application to Reinstate Expired Electrical Contractors License #17831 received from Franco Catalioti.

Office files reflect that Mr. Catalioti's License and Business Permit #17831 expired on March 31, 2021.

Office files do not reflect that the pressure seal issued to Electric Pro's LLC has been returned to the Board office.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, that this matter be discussed in Executive Session.

Mr. Papademas is recused from the following discussion and motion as he was the instructor for continuing education.

The Board reviewed an Application to Reinstate Expired Electrical Contractors License #10517 received from Joseph M. Angello, License #10517.

Office files reflect that Mr. Angello's License and Business Permit #10517 expired on March 31, 2012.

The Board had requested that Mr. Angello provide a more detailed description of the work he had been performing since 2012.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, that this matter be discussed in Executive Session.

March 15, 2023

The Board reviewed an Application to Reinstate Expired Class A Journeyman Electrician #6555 received from Harry T. Lauletta.

Office files reflect that Mr. Lauletta's journeyman registration #655 expired on December 31, 2021.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to reinstate Mr. Lauletta's Class A Journeyman Electrician #6555 as he has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement.

The Board reviewed an Application for Continuing Education Course/Seminar approval received from Dina Pomarico, Phoenix Safety & Associates, LLC, requesting approval to add an instructor to previously approved courses and approval of new courses.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to approve seven (7) new courses and one instructor.

The Board reviewed an Application for Continuing Education Course/Seminar approval received from Joanna Osoliniec, Institute for Technical Advancement, LLC, requesting approval to teach three new courses.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to approve three (3) new courses and one instructor.

The Board reviewed an Application for Continuing Education Course/Seminar approval received from Scott K. Pomarico, Sr. requesting approval to teach twenty (20) new courses and one new instructor.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to approve twenty (20) new courses and one instructor.

The Board reviewed an Application for Continuing Education Course/Seminar approval received from Dana Villari, Warshauer Electric Supply, requesting approval of one instructor to teach a previously approved course.

March 15, 2023

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, that Ms. Villari's request be held in abeyance pending a more detailed resume for Michael Conway to substantiate his qualifications to teach the course entitled "Electric Heat for Residential and Commercial Installations".

The Board reviewed an Application for Continuing Education Course/Seminar approval received from Neil G. Nagy, Father Time Seminars, requesting approval to teach two (2) new courses.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to approve two (2) new courses and one instructor. Additionally, Mr. Nagy will be requested to provide a separate certificate to licensees for the two (2) hour gas piping installation course so that the license can present this certificate to the building department.

The Board reviewed an Application for Continuing Education Course/Seminar approval received from Marcel Renson requesting approval to teach two new courses and add an instructor to previously approved courses.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, to approve Mr. Renson's request to allow his son, Marcel Renson, IV, to assist him when teaching continuing education courses. Marcel Renson, IV is approved to assist with teaching the two (2) new courses and the sixteen (16) previously approved courses. Mr. Renson must be present during the periods his son is teaching. Additionally, an instructor number will not be issued to his son. The Board asks that Mr. Renson's son teach/assist at least six courses and then he can submit an application to become an approved continuing education instructor.

Mrs. Tucker stated that the members of the Pools and Spas Committee would like to meet with the Electrical Board regarding the servicing of pool heaters.

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve Mr. Schooley and Mr. Papademas to serve on a subcommittee to meet with the members of the Pool and Spa Advisory Committee.

March 15, 2023

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Gino Pasqualone, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
