The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (14) Initial Licenses which will expire on March 31, 2024.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (14) Initial Business Permits which will expire on March 31, 2024.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (6) of the (7) Initial Business Permits Previously Expired effective April 14, 2021 to March 31, 2024. (#1, #2, #3, #4, #6, and #7 are being held in abeyance pending further review).

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve (4) of the (11) Changes in Business Permits effective April 14, 2021 to March 31, 2024. (#1 #2, #3, #4, #7 #9, and #11 are being held in abeyance pending further review).

Motion made by Mr. James H. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve the Minutes of the 955rd Open Session Business Meeting held March 17, 2021.

Anna Bennett, Regulatory Analyst, appeared before the Board to discuss <u>N.J.A.C.</u> 13:31.1.7 the proposed draft of amendments to the continuing education proposal regarding distance learning.

Ms. Bennett stated that at the April meeting, the Board requested that changes be made to the drafted proposed language. Ms. Bennett stated that she changed the proposed language to include the number of credits as follows:

N.J.A.C. 13:31-1.7(d) (5) (maximum of 8) for the successful completion of a United States Department of Labor OSHA approved online safety course per triennial registration;

<u>N.J.A.C.</u> 13:31-1.7(d) (6) (maximum of 24) for the successful completion of a course approved by the State Board of Professional Engineers and Land Surveyors per triennial registration;

<u>N.J.A.C.</u> 13:31-1.7(d) (7) (maximum of 2) for the successful completion of a program in the installation of natural or manufactured gas piping relevant to installing or repairing electric generators per triennial registration period.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the proposed drafted language in N.J.A.C. 13:31-1.7.

Check in the amount of \$150.00 received from John A. Schipani, License #14228, t/a John A. Schipani Electrical Contractor, as the ninth installment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:5A-9(a). Payments began February 20, 2020 and the balance due is \$500.00.

Check in the amount of \$150.00 received from Craig J. Kostick, License #8288, as the first installment of a civil penalty in the amount of \$4,000.00 for violation of $\underline{\text{N.J.A.C.}}$ 13:31-3.3 (c) (1). The balance due is \$3,850.00.

The Board accepted the payment.

Check in the amount of \$50.00 received from George Isabella, License #14732, t/a George Isabella Electrical Contractor, as the thirty-second installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:31-3.3(c) (1). Payments began July 27, 2018 and the balance due is \$800.00.

The Board accepted the payment.

Two checks in the amount of \$150.00 received from Christopher Meyers, License #13140, as the fifth and six installment of a civil penalty in the amount of \$6,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments started October 14, 2020 and the balance due is \$5,100.00.

The Board accepted the payment.

Check in the amount of \$150.00 received from Albert G. Hoesly, License #13598, as the second installment of a civil penalty in the amount of \$4,000.00 for violation of $\underline{\text{N.J.A.C.}}$ 13:31-3.3 (c) (1). Payments started March 2, 2021 and the balance due is \$3,700.00.

The Board accepted the payment.

Checks in the amount of \$150.00 received from Kenneth Gorman, License #13786, as the second and third installment of a civil penalty in the amount of \$5,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments started January 19, 2021 and the balance due is \$4,550.00.

The Board accepted the payment.

Postal Money Order in the amount of \$600.00 received from Robert A. Gramlich, License #12898, t/a Robert A. Gramlich Electric, as the sixth installment of a civil penalty in the amount of \$6,000.00 for violation of <u>N.J.A.C.</u> 13:31-3.3(c). Payments started January 9, 2020 and the balance due is \$3,300.00.

The Board accepted the payment.

The Board accepted the payment.

The Board accepted the payment.

Check in the amount of \$5,000.00 received from Richard Pantalone, Unlicensed, as the first and final payment of a civil penalty in the amount of \$5,000.00 for violation of N.J.S.A. 45:5A-9(a). Mr. Pantalone signed an agreement to cease and desist from engaging in the business of electrical contracting until he becomes licensed.

The Board accepted the payment.

Letter dated February 3, 2021, from Sundeep Anand, Vice President, A & S Electrical Inc., requesting a six-month continuance of business under Permit #13516 according to N.J.S.A. 45:5A-14. The licensee, Altaf H. Syed-Naqvi, died on January 24, 2021.

Mr. Anand stated he has been with the company for 20 years.

Motion made by James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the firm of A&S Electrical, Inc., be granted a six-month continuance of business under permit #13516 pursuant to N.J.S.A. 45:5A-14. The Board approves Mr. Anand to qualify the business. The extension will expire on June 25, 2021.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Bernie Corrigan, IBEW Local #102, requesting approval to teach new courses and previously approved instructors. Mr. Corrigan's request was held in abeyance pending receipt of resumes for the previously approved instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve nine (9) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Warren M. Becker, IBEW Local #164, requesting approval to teach new courses and instructors.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve nine (9) new courses and instructors.

Mr. Papademas recused himself from the following discussion and motion, as he is one of the instructors teaching courses under the sponsorship of IBEW Local #164.

The Board reviewed an application for Continuing Education Course/Seminar approval received from John A. Delesandro, NJ Department of Community Affairs, Rutgers University, requesting approval to teach new courses and instructors.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Gino Pasqualone, and passed, to approve thirty-eight (38) new courses and instructors.

Letter dated March 26, 2021, received from David J. Sands, License #16531, requesting an extension to fulfill his Continuing Education Courses pursuant to N.J.S.A. 45:5A-13.4.

Office files reflect that Mr. Sands' was issued his business permit on April 8, 2014, which expired on March 31, 2015. A pressure seal was never ordered for DMC Services, LLC.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Sands' request is denied at this time. Mr. Sands will be requested to provide the Board with a doctor's note explaining the reason why he was not able to attend continuing education courses either in person or via a webinar.

Mrs. Tucker stated that she has nothing to report to the Board.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Gino Pasqualone, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.

Meeting adjourned at 2:00 P.M.
