

941st BUSINESS MEETING OF THE BOARD OF EXAMINERS OF
ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JUNE 12, 2019

Board meeting of June 12, 2019, was called to order at 9:00 A.M.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Also in attendance were Julian Perez; Kara Foley, Princeton Public Affairs Group and Nicholas Barra.

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve eleven (11) Initial Licenses which will expire on March 31, 2021.

June 12, 2019

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve ten (10) Initial Business Permits which will expire on March 31, 2021.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve four (4) Initial Business Permits Previously Expired effective June 12, 2019 to March 31, 2021.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve three (3) of the five (5) Changes in Business Permits effective June 12, 2019 to March 31, 2021. (#3 and #5 are being held in abeyance pending further review).

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve the Minutes of the 940th Open Session Business Meeting held May 8, 2019.

Two checks in the amount of \$167.00 each received from Alfredo Oristanio, License #14835, as the fourth and fifth installment of a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments began January 17, 2019 and the balance due is \$1,165.00.

The Board accepted the payments.

Check in the amount of \$50.00 received from George Isabella, License #14732, t/a George Isabella Electrical Contractor, as the tenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Payments began July 27, 2018 and the balance due is \$1,850.00.

The Board accepted the payment.

June 12, 2019

Check in the amount of \$167.00 received from Barry J. Yeslow, License #9340, as the twelfth and final payment of a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1).

The Board accepted the payment.

Check in the amount of \$250.00 received from Anthony Vignali, License #14343 (Suspended), as the second installment of a civil penalty in the amount of \$10,000.00 for violation of N.J.S.A. 45:5A-9. Payments started April 11, 2019 and the balance due is \$9,500.00.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from Christopher M. Cecere, License #18184, t/a Elite Power and Light, LLC, as the sixth installment of a civil penalty in the amount of \$8,000.00 for violation of N.J.S.A. 45:5A-15. Payments began December 4, 2018 and the balance due is \$1,000.00.

The Board accepted the payments.

Check in the amount of \$2,000.00 received from Miladin Radovanovich, Unlicensed, as the first and final payment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:5A-9. Mr. Radovanovich also signed an agreement to cease and desist from engaging in the business of electrical contracting until such time as he becomes licensed.

The Board accepted the payment.

June 12, 2019

Check in the amount of \$2,000.00 received from John Radovanovich, Unlicensed, as the first and final payment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:5A-9. Mr. Radovanovich also signed an agreement to cease and desist from engaging in the business of electrical contracting until such time as he becomes licensed.

The Board accepted the payment.

Check in the amount of \$1,000.00 received from Carl Moore, License #9502, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:31-1.2; N.J.A.C. 13:31-3.1; and N.J.A.C. 13:31-3.3(h).

The Board accepted the payment.

Mr. Schooley stated for the record that sponsors will be allowed to teach the nine hours of code changes on the 2020 code and the one hour of laws, rules, and regulations beginning January 1, 2020.

Mr. Flaherty stated for the record that he knows Mr. Rieth.

The Board reviewed an application for Continuing Education Course/Seminar approval received from William Rieth requesting approval to teach the nine hours of code changes and one hour of laws, rules, and regulations.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve Mr. Rieth's request to teach the nine hours of code changes on the 2017 code and the one hour of laws, rules and regulations.

June 12, 2019

Mr. Constantinos Papademas recused himself from the following discussion and motion as he is listed as an instructor.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Doug Chapman, HalfMoon Education, Inc., requesting approval of new courses.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and passed, to approve one (1) new course and an instructor.

The Board reviewed an Application to Reactivate an Inactive Electrical Contractors License received from Julio A. Ramirez, License #14566 (Inactive).

Office files reflect Mr. Ramirez chose Inactive status for his License and Business Permit #14566 on March 2, 2018.

Pressure seal issued to Expeditors, Mediators & Contractors, LLC returned to the Board office on March 1, 2018.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Ramirez be scheduled to appear before the Board to discuss his request for reactivation. The Board has concerns about Mr. Ramirez requesting a waiver of the continuing education requirement, but is seeking to reinstate his business permit. Additionally, the Board notes the social security documentation indicates "If the claimant has the residual functional capacity to do his past relevant work, the claimant is not disabled".

The Board reviewed an Application to Reactivate an Inactive Electrical Contractors License received from Mark E. Young, License #15192 (Inactive).

Office files reflect Mr. Young chose Inactive status for his License and Business Permit #15192 on May 31, 2009.

June 12, 2019

Pressure seal issued to Manweb Services, d/b/a Enterprise Electrical and Mechanics, returned to the Board office on May 2, 2019.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

The Board reviewed an Application for Reinstatement of a License received from Damian A. Campbell, License #15643 (Expired).

Office files reflect License and Business Permit #15643 expired on March 31, 2018.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

After a discussion in Closed Session, the Board returned to Public Session for the following motion.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, to reinstate Mr. Campbell's License #15643 as he has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement.

The Board reviewed an Application for Reinstatement of a License received from Daniel R. Tyler, License #16990 (Expired).

Office files reflect License and Business Permit #16990 expired on March 31, 2015.

Office files also reflect that the pressure seal issued to ACR Electric, LLC was not returned to the Board office.

June 12, 2019

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

The Board reviewed an Application for Reinstatement of a License received from Robert F. Beagen, License #9799 (Expired).

Office files reflect License #9799 expired on March 31, 2018. Office files also reflect that Mr. Beagen chose inactive status for Business Permit #9799 on November 6, 2014.

Office files also reflect that the pressure seal issued to Great Escapes Ski, Pool and Patio, LLC was returned to the Board office on November 6, 2014.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

Signed cease and desist agreement received from Stephen Lagreca, License #14384 (Expired), agreeing to cease and desist from engaging in the business of electrical contracting until such time as his license and business permit are reinstated.

The Board accepted the signed cease and desist agreement.

Response received from Nelson Morales to the Final Order of Discipline filed April 10, 2019, ordering License and Business Permit #6974 be suspended until such time as Mr. Morales cooperates with the Board's request to provide copies of W-2 income tax forms.

June 12, 2019

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be discussed in Executive Closed Session.

Mrs. Tucker stated that she has nothing to report to the Board.

Mr. Flaherty stated in regards to the amended regulation concerning the qualifications of examination, the Board needs direction as to how an applicant qualifies.

DAG Donofrio stated that the law was amended on December 17, 2018. Applicants that provide documentation to substantiate they have acquired five years of practical hands on experience before December 17, 2018, will not be required to provide an apprenticeship completion certificate.

The Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Twenty-six (26) applications were approved.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
