June 14, 2017

The Minutes of the 918<sup>th</sup> Open Session Business Meeting held May 10, 2017, were not ready for approval.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (13) Initial Licenses which will expire on March 31, 2018. (Licenses were issued from May 25, 2017 through June 7, 2017).

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (11) Initial Business Permits which will expire on March 31, 2018. (Licenses were issued from May 25, 2017 to June 7, 2017)

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (3) Initial Business Permits Previously Expired effective June 14, 2017 to March 31, 2018.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (2) Changes in Business Permits effective June 14, 2017 to March 31, 2018.

Two payments in the amount of \$1,000.00 each received on April 17 and May 16, 2017, from Edward Johnson, License #7469 (Revoked), as the eight and ninth installment of a civil penalty in the amount of \$30,000.00 for violation of N.J.S.A. 45:5A-9; N.J.A.C. 13:31-1.5(e); and N.J.S.A. 45:1-21(e). Payments began on November 16, 2016 and the balance due is \$22,000.00.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Alan Chech, Alan Chech Electrical Seminars, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed to approve, three (3) new courses and instructors.

June 14, 2017

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dwight C. Price, The Electrical Association of Philadelphia, requesting approval of a new course.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve one (1) new course and an instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Joanne Vander Kooy, National Technology Transfer, Inc., requesting approval of new instructors to teach previously approved courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve nine (9) instructors to teach previously approved courses. The remaining instructors are disapproved as the Board does not feel they are qualified to teach the courses listed.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Levi C. Bell, Jr., along with a more detailed breakdown of the course content for the course entitled "NEC Article 680".

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that Mr. Bell's request to teach the course entitled "NEC Article 680" is being held in abeyance pending a more detailed outline of the course content.

At its April 12, 2017 meeting, the Board reviewed an application for Continuing Education Course/Seminar Approval received from Fredric Smith. The Board approved the course entitled "24 Hour Electrical Trade Practices"; however, the course entitled "9 Hours of Electrical Code and One Hour of Law" was held in abeyance pending clarification as to whether or not Mr. Smith is requesting to teach the nine hours of code changes for the current 2017 Code or is he requesting to teach code changes on the 2014 code.

E-mail dated May 1, 2017, received from Mr. Smith stating he will focus on the most recent 2017 code changes and the changes in the 2014 code.

June 14, 2017

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that Mr. Smith's request to teach the "9 Hours Electrical Code and One Hour of Law" is being held in abeyance. Pursuant to N.J.A.C. 13:31-1.7 (c) licensees are required to complete a ten hour course of study relating to the most recent edition of the National Electrical Code (nine hours of which shall pertain to the code and one hour of which shall pertain to applicable State statutes and rules). Therefore, if Mr. Smith wishes to teach nine hours of code changes on the 2017 and 2014 code, the Board cannot approve such a course as part of the "ten hour course of study". Mr. Smith will be requested to clarify for the Board how he wishes to proceed regarding his request to teach this particular course.

\*\*\*\*\*

Mr. Flaherty requested that the Board discuss at a future date whether or not licensees should be required to take a five hour NFPA 70E course. Mr. Flaherty also stated the five hours would be part of the 24 hours of continuing education already required of licensees.

This matter will be placed on the September agenda.

The Board reviewed an application for Reinstatement of a license received from Richard K. Cotterell, License #12030 (Expired).

Office files reflect Mr. Cotterell's License #12030 expired on March 31, 2009.
