The Board saluted the Flag.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve (3) Initial Licenses which will expire on March 31, 2021.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to approve (7) Initial Business Permits which will expire on March 31, 2021.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (2) Initial Business Permits Previously Expired effective July 30, 2020 to March 31, 2021.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (4) of the (5) Changes in Business Permits effective July 30, 2020 to March 31, 2021. (#2 is being held in abeyance pending further review)

Pursuant to N.J.S.A. 45:5A-5 the Board shall elect a chairman to preside over the meetings and an executive director to serve the Board during the period of July 30, 2020 to June 30, 2021.

Mr. Constantinos Papademas nominated Mr. Joseph P. Schooley, and the nomination was seconded by Mr. Anthony L. Anzelone.

Let the record reflect that Mr. Schooley has been elected Chairman for the Board from this date until the July 2021 meeting pursuant to N.J.S.A. 45:5A-5.

Mr. James H. Flaherty nominated Philameana L. Tucker, and the nomination was seconded by Mr. Anthony L. Anzelone.

Let the record reflect that Mrs. Tucker has been elected Executive Director for the Board from this date until the July 2021 meeting pursuant to N.J.S.A. 45:5A-5.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Yehudit Gelb, School of Electrical Education, requesting approval to teach new courses and new instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve one (1) new course and instructor. Mr. Gelb will be advised that the course entitled NYC License Renewal Class is not approved as it does not meet the requirements of continuing education (course is for New York City master electricians).

The Board reviewed an application for Continuing Education Course/Seminar approval received from Donald A. Clare, New Jersey Education and Seminars, LLC, requesting approval to teach new courses and new instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve three (3) new courses and instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, that a letter be sent to Ms. Yencich advising that the courses submitted have not been approved. Ms. Yencich will be requested to describe how the courses will be conducted and how they will assure the attendee is taking these courses. The courses may not even meet the criteria of continuing education as it appears that the course(s) are "video" courses and not instructor led.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Sarah Hagy, The Electrical Association of Philadelphia, requesting approval to teach one new course and an instructor.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve one (1) course and instructors.

The Board reviewed an application for Continuing Education Course/Seminar approval received from Dione Johns, National Technology Transfer, Inc., requesting approval to teach of new courses and instructors.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to conditionally approve three (3) courses and instructors. The Board requests that the sponsor indicate the name of each instructor teaching each respective course.

The Board reviewed an application to Reinstate an Expired Electrical Contractors License received from Brian W. Anacker, License #17288.

Office files reflect Mr. Anacker's License #17288 expired on March 31, 2018.

Office files do not reflect that the pressure seal issued to Anacker Electric, LLC, has been returned to the Board office.

Motion made by Mr. James H. Flaherty and seconded by Mr. Anthony L. Anzelone, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reinstate an Expired Electrical Contractors License received from John E. Pakenham, III, License #16471.

Office files reflect Mr. Pakenham's License and Business Permit #16471 expired on March 31, 2018.

Office files also reflect that Mr. Pakenham paid to renew his business permit on February 3, 2018. However, the business permit was not updated as he never submitted payment to renew his license.

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reinstate an Expired Electrical Contractors License received from Edmund C. Williams, License #8117.

Office files reflect Mr. Williams' License and Business Permit #8117 expired on March 31, 1994.

Office files also reflect that the pressure seal issued to Electrical Erectors, Inc, was returned to the Board office on August 4, 1992.

Mr. Papademas stated for the record that Mr. Williams attended his continuing education classes; therefore, he is recusing himself from the discussion and the motion.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. James H. Flaherty, and passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reinstate an Expired Electrical Contractors License received from Richard G. Rohrbach, Jr., License #10236.

Office files reflect Mr. Rohrbach's License and Business Permit #10236 expired on March 31, 1991.

Mr. Rohrbach provided a letter stating the pressure seal issued to R.G. Rohrbach & Sons, Inc. was in his car at the time he was involved in an accident. The seal was never found.

Motion made by Mr. James J. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reinstate an Expired Electrical Contractors License received from Michael J. Strippoli, License #8043.

Office files reflect Mr. Strippoli's License #8043 expired on March 31, 2000.

Office files also reflect that Mr. Strippoli's Business Permit #8043 expired on March 31, 1997.

Office files reflect that the pressure seal issued to Michlyn Electrical Contractors was returned to the Board office on November 22, 2019.

Motion made by Mr. James J. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reactivate an Inactive Electrical Contractors License received from Richard Agnello, License #18050.

Office files reflect Mr. Agnello chose Inactive status for his License and Business Permit #18050 on January 24, 2017.

Office files do not reflect that the pressure seal issued to Agnello Electrical Contracting, LLC has been returned to the Board office.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. Constantinos Papademas, and unanimously passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reactivate an Inactive Electrical Contractors License received from Todd J. Ciamei, License #16604.

Office files reflect Mr. Ciamei chose Inactive status for his License and Business Permit #16604 on March 30, 2015.

Office files do not reflect that the pressure seal issued to Heights Electric, LLC has been returned to the Board office.

Motion made by Mr. James H. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reactivate an Inactive Electrical Contractors License received from Steven Sadowski, License #7448.

Office files reflect Mr. Sadowski chose Inactive status for his License and Business Permit #7448 on March 17, 2003.

Office files also reflect that the pressure seal issued to S & A Electrical Contractors was returned to the Board office on March 5, 2020.

Motion made by Mr. James H. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, that this matter be held in abeyance and discussed during the next scheduled Closed Session Meeting.

The Board reviewed an application to Reactive an Inactive Electrical Contractors License received from Anthony Voiro, License #12112.

Office files reflect Mr. Voiro chose Inactive status for his License #12112 on March 25, 2003.

Office files also reflect that Mr. Voiro withdrew his business permit on January 7, 2002.

Office files further reflect that Mr. Voiro returned the pressure seal issued to Leston Electric on January 7, 2002.

Motion made by Mr. James H. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to reinstate Mr. Voiro's License #12112 as he has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement. Mr. Voiro will be advised that the certificates he submitted were required for the 2018 cycle. Therefore, he must complete another 34 hours before March 31, 2021, in order to renew for the 2021 cycle. These courses cannot be a duplicate of the courses he attended for his 2018 cycle.

Letter dated March 5, 2020, received from Mary Ann Edmond requesting a six-month continuance of business under Permit #6556 according to N.J.S.A. 45:5A-14. The licensee, John C. Edmond Jr., died on February 11, 2020.

Mrs. Edmond stated that Christopher Dietz has been with the company working as an electrical technician and foreman for the past twenty years and will complete the jobs already in progress.

Motion made by James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, due to the Coronavirus Pandemic the Board will automatically grant two six-month continuances of business to the firm of JEC Electric Inc. under permit #6556. The extension will expire on February 11, 2021. The Board approves Christopher Dietz to qualify the business for the twelve-month period.

Letter received March 17, 2020, from Erich Jaeckle requesting a second six-month continuance of business under Permit #11548 according to N.J.S.A. 45:5A-14. The licensee, Reiner E. Jaeckle, died on August 25, 2019.

Erich Jaeckle stated that he is in the process of submitting his application for examination.

Office files reflect that the six-month extension expired on March 25, 2020.

Motion made by James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the firm of Metro-Tek Electrical Services Company be granted two six-month continuances of business under permit #11548.

Due to the Coronavirus Pandemic, Mr. Jaeckle, who was approved to qualify the business, did not have the opportunity to take the electrical contractors examination. The extension will expire on March 25, 2021.

The Board discussed extending the following regulations as the testing centers were closed as part of an executive order signed by the governor during the Coronavirus Pandemic.

<u>N.J.A.C.</u> 13:31-2.2(d) if an applicant fails to obtain a passing score on all sections of the Board licensing examination within five years of the date of approval to take the examination for the first time, the application for licensure shall be deemed abandoned and closed.

<u>N.J.A.C.</u> 13:31-2.2(e) if an applicant fails to sit for the Board licensing examination within two years of the date of approval to take the examination for the first time, application for licensure shall be deemed abandoned and closed.

Mrs. Tucker stated that due to the Coronavirus Pandemic the testing center was closed; therefore, many applicants were unable to take the examination. At the present time, only ten applicants are allowed in the room to take the examination.

Mr. Flaherty stated that because of the Pandemic, the Board should allow an extension to those applicants who have already been approved.

DAG Donofrio stated that the Board should waive the regulatory restriction on a case by case basis.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, to authorize the Chairman to make those decisions on a case by case basis.

All approved Continuing Education sponsors were advised that the Board determined the entire 34 hours of continuing education required for the April 1, 2021 renewal may be presented as webinars, written, or electronic media distance learning courses. Sponsors were also advised that they must comply with the requirements of N.J.A.C. 13:31-1.7(h).

Mr. Schooley stated since the Board had already drafted language to allow distance learning, he made the decision to allow all thirty four hours to be taught on-line for the 2021 renewal.

Motion made by Mr. James H. Flaherty and seconded by Anthony L. Anzelone, and unanimously passed, to ratify the Chairman's decision to allow on-line education for those courses that were previously approved for in-person instruction.

The Board reviewed Assembly Bill No. 4225 which provides that, notwithstanding the provisions of any other law, lawful presence in the United States may not be required to obtain a professional or occupational license, provided that the applicant meets all other requirements for licensure.

Mrs. Glasgow stated assuming all other regulations are met, lawful presence would not be required to obtain licensure; therefore, unlawful presence would not be a barrier.

Motion made by Mr. Anthony L. Anzelone and seconded by Mr. James H. Flaherty, and unanimously passed, that the Board has a neutral, non-comment position.

The Board reviewed Senate Bill No. 2419 (introduced May 7, 2020) which would regulate the installation, maintenance and repair of perimeter fence intrusion protection systems, and other alarm systems governed by The Electrical Contractors Licensing Act of 1962.

The bill would also establish confidentiality standards for alarm service practitioners and licensed locksmiths. The bill would restrict local government regulation of the installation and maintenance of a perimeter fence intrusion protection system, as long as the system meets the definition of the system established by the bill and several additional requirements.

The Board also reviewed the amended version of Senate Bill No. 2419 (amended June 29, 2020) which stated a licensee shall ensure the confidentiality of information obtained from a client. The bill also indicated that the bill shall not be construed to authorize anyone other than a licensed electrical contractor holding a valid business permit to install, service, or maintain any wiring that exceeds thirty (30) volts.

Mrs. Glasgow stated that the bill was recently amended to ensure the confidentiality of information obtained from the client. Penalties would be issued for the failure to comply with maintaining such confidential information.

Mr. Papademas stated the language is not clear. According to the Board's rules and regulations, electrical work exceeding ten volts must be performed by a licensed electrical contractor with a business permit.

Mr. Flaherty stated that magnetic locks, which exceed 24 volts, must be installed by a licensed electrical contractor. Mr. Flaherty also stated that the language reflected in the bill is similar to the work reflected in the petition by CEDIA. Power Over the Ethernet operates at 48 volts and an electrical contractor is needed to make that final connection. Mr. Flaherty also stated that he concurs with Mr. Papademas that the language is nebulous.

Motion made by Mr. James H. Flaherty and seconded by Mr. Anthony L. Anzelone, and unanimously passed, the Board objects to Senate Bill 2419 as amended on June 13, 2020 as the work described in the bill exceeds the current voltage limitation of ten volts. It is not the board's intent to modify the voltage of the detection systems duly installed by the fire and burglar alarm and locksmith installers. However, the ancelory equipment must be installed by a licensed electrical contractor and/or a fire, burglar, and locksmith licensee.

Mrs. Glasgow introduced her colleague, Anna Bennett, who will be taking over as the regulatory analyst for the Electrical Board. Mrs. Glasgow also stated that she has been working with Anna for eight years and appreciates the time she have worked with her. Mrs. Glasgow further stated she will assist Anna with any pending legislation and will continue to handle the Power Over the Ethernet issue.

Mr. Schooley stated that the Board has certainly enjoyed working with Rachel and appreciates her dedication and wishes her well on her new assignment. Mr. Schooley welcomed Ms. Bennett and stated that the Board looks forward to working with her.

The Board discussed N.J.S.A. 45:5A-18(m) which states electrical work or construction which is performed on the following facilities or which is by or for the following agencies shall not be included within the business of electrical contracting so as to require the securing of a business permit under this act:

(m) The maintaining, installing or connecting of automatic oil, gas or coal burning equipment, gasoline or diesel oil dispensing equipment and the lighting in connection therewith to a supply of adequate size at the load side of the distribution board.

Mr. Schooley stated due to the licensing of HVACR contractors, the Board should draft a new regulation to clarify N.J.S.A. 45:5A-18(m). The exemption should only exempt the installation of gas and diesel oil dispensing equipment. The language regarding the lighting in connection to the distribution board should be deleted.

Mr. Flaherty stated that the code is very intense and difficult concerning the installation of fuel dispensing equipment; therefore, it is his opinion that a qualified journeyman should perform this work.

DAG Donofrio stated he is concerned with restricting work to be performed only by a qualified journeyman.

Mr. Schooley stated this matter was brought to his attention because an inspector wanted to deny an application for work to be performed at a gas station. The inspector did not know the contractor was allowed to perform this work.

This matter is being held in abeyance and will be discussed at a later date.

The Board discussed allowing the chairman to make executive decisions on behalf of the Board in the absence of a meeting.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that due to the Coronavirus Pandemic, if there are issues concerning the electrical contracting industry, the Board allows the Chairman to make executive decisions about critical issues that arise in the absence of a Board meeting. The decisions will then be presented to the full Board for affirmation.

Mrs. Tucker stated because of the restrictions placed by the Governor due to the Coronavirus Pandemic, she has received many requests from candidates asking that they be allowed to test in the state they reside. Mrs. Tucker also stated that the contract does not prohibit the applicant from taking the test in the state in which they reside and PSI will be required to ensure that the applicant is taking the New Jersey examination.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that the applicant be allowed to take the examination in another state as long as PSI ensures that all criteria is met regarding the examination. The Board also determined that applicants be allowed to take the examination in another state even when not in the midst of a Pandemic.

Mr. Papademas asked Mrs. Tucker to contact PSI and request that they update the candidate bulletin and test candidates on the 2019 NFPA-72 Code. Candidates are currently being tested on the NFPA 2013 Code.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Anthony L. Anzelone, and unanimously passed, to adjourn Public Session.

Meeting adjourned at 2:00 P.M.
