Charles Manning, Regulatory Analyst, Division of Consumer Affairs, appeared before the Board to discuss whether the Board can waive the Continuing Education provision under *N.J.A.C. 13:45C* for Class A Journeymen and Class B Wiremen.

Mr. Manning stated the Board already has a regulation to waive continuing education requirements on an individual basis due to hardship, severe illness, disability etc. However, the Board has not adopted the regulations concerning Class A Journeymen and Class B Wiremen. Mr. Manning also stated that the statute states a Class A Journeyman Electrician must complete 15-hours of continuing education to renew the and the Board cannot waive a statutory provision.

DAG Donofrio stated that the Board does not want to waive the continuing education requirement; the Board would like to waive the manner in which the licensee can take continuing education courses.

Mr. Anzelone stated that the Board is requesting that journeymen be allowed to take their continuing education courses on-line.

Mr. Manning stated he would also like to discuss with the Board the draft concerning the use of electronic seals and signatures.

Mr. Manning stated in order to utilize the submission of electronic seals and signatures, the licensee will need both the software and the plug-in device in order to submit the permit.

DAG Donofrio asked how the Board would disable that contractor's ability to obtain a permit if the license and business permit are suspended or revoked.

Mr. Manning stated he was unsure how the Board would impound the software.

Mr. Flaherty stated many of the complaints received by the Board deal with unlicensed contractors who have been able to submit a permit using another contractor's seal.

Anthony Menafro, Department of Community Affairs, stated in lieu of the seal on the application, there will now be a water mark that is purchased from an outside agency. Mr. Menafro stated he will answer any questions the Board or public may have regarding this matter.

Mr. Menafro asked that his contact information be entered into the minutes.

Mr. Schooley stated that he is stepping down as Chairman of the Board. Mr. Schooley also stated he has always taken his job very seriously and it has been a pleasure to work with everyone during his tenure. Mr. Schooley further stated he will miss everyone and appreciates Kathleen, Joe Donofrio and Philameana who have made his tenure easy and pleasant.

Mr. Flaherty stated Mr. Joseph Schooley has dedicated decades of service as the chair of the New Jersey Board of Examiners of Electrical Contractors. Throughout his tenure, he has demonstrated a profound understanding of the electrical industry, along with the regulatory statutes and procedures that govern the board. His leadership has been instrumental in steering the board through numerous complex and sometimes unexpected challenges.

One of the notable aspects of Mr. Schooley's leadership was his ability to coordinate effectively with the board's advisory groups, including the Fire, Burglar Alarm, and Locksmith Advisory Board (FBL) and those overseeing swimming pool installations. These collaborations often brought to light the overlaps between electrical installations and regulations from newer entities, such as the HVAC Board and swimming pool installation guidelines. Such overlaps sometimes led to contentious discussions during board meetings, yet Mr. Schooley managed these situations with a steady hand.

Recently, he has been involved in revising the electrical licensing requirements for journeymen, apprentices, and electrical workmen. These revisions have introduced new administrative requirements, adding to the workload, and impacting the board's staff. Joe Schooley's leadership as chairperson of the New Jersey Board of Examiners of Electrical Contractors has also been crucial in navigating significant changes to the board's staff and professional advisors. These changes often required his direct intervention to address and resolve immediate challenges. Under his guidance, the board managed to maintain its functionality and effectiveness, despite the disruptions that staffing changes can bring. Schooley's intervention ensured that the board could continue to operate smoothly, implementing effective solutions for short-term problems as they arose. His ability to adapt and respond to these changes demonstrated his commitment to the board's mission and the electrical industry at large. His efforts ensured that the board remained resilient and capable of meeting its regulatory responsibilities, even in the face of staffing upheavals and the evolving demands of the electrical contracting industry. Complicating these matters, the board has faced a significant reduction in its members due to the lack of new appointments by the governor, which has placed additional responsibilities on Mr. Schooley's shoulders. Despite these challenges, he has remained diligent, often delegating tasks to subcommittees, such as collaborating with the board's testing vendor to ensure the technical accuracy of licensing examination questions.

Throughout all these tasks, Joe Schooley has consistently brought diligence and good humor to his role, leaving a lasting impact on the New Jersey Board of Examiners of Electrical Contractors, and setting a high standard for those who will follow in his footsteps.

Howard Pine, Deputy Director, Division of Consumer Affairs, stated he cannot say enough about Mr. Schooley's service to the State, and he has been an incredible chairman. Mr. Pine also stated that he is both happy and sad that Mr. Schooley is leaving and knows that it was a difficult decision. Mr. Pine also stated that Mr. Schooley will be given a certificate of appreciation for his 30 years of service.

Mr. Schooley thanked everyone for their kind words.

Mr. Schooley also stated at this time he would like to nominate a new chairman.

Mr. Joseph P. Schooley nominated Mr. James H. Flaherty, and the nomination was seconded by Mr. Anthony L. Anzelone.

Let the record reflect that Mr. Flaherty has been elected Chairman for the Board from this date until the July 2025 meeting pursuant to *N.J.S.A. 45:5A-5*.
