

935th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - DECEMBER 12, 2018

The Board saluted the Flag.

December 9, 2018

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (4) Initial Licenses which will expire on March 31, 2021.

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (2) Initial Business Permits which will expire on March 31, 2021.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (5) of the (6) Initial Business Permits Previously Expired effective December 12, 2018 to March 31, 2021. (#1 is being held in abeyance pending receipt of additional information).

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (5) Changes in Business Permits effective December 12, 2018 to March 31, 2021.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the Minutes of the 933rd Open Session Business Meeting held October 10, 2018.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the Minutes of the 934th Open Session Business Meeting held November 7, 2018.

Check in the amount of 4,250.00 received on October 15, 2018, from James R. Kennedy, License #8781, t/a J K Electric, Inc., as the first installment of a civil penalty in the amount of \$17,000.00 for violation of N.J.S.A. 45:5A-9; N.J.A.C. 13:31-1.2; N.J.A.C. 13:31-3.4 and N.J.A.C. 13:45C-1.2. Balance due is \$12,750,00.

The Board accepted the payment.

December 12, 2018

Payment in the amount of \$1,000.00 received on October 16, 2018, from Edward Johnson, License #7469 (Revoked), as the twenty-third installment of a civil penalty in the amount of \$30,000.00 for violation of N.J.S.A. 45:5A-9; N.J.A.C. 13:31-1.5(e); and N.J.S.A. 45:1-21(e). Payments began on November 16, 2016 and the balance due is \$6,000.00.

The Board accepted the payment.

Check in the amount of \$167.00 received on October 24, 2018, from Kevin A. Laddy, License #16206, as the first installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:31-3.3 (c) (1). Balance due is \$833.00.

The Board accepted the payment.

Check in the amount of \$250.00 received on October 26, 2018, from Michael R. Day, Unlicensed, as the first and final payment of a civil penalty in the amount of \$250.00 for violation of N.J.S.A. 45:5A-9. Mr. Day also signed an agreement to cease and desist from engaging in the business of electrical contracting in the State of New Jersey until such time as he becomes licensed.

The Board accepted the payment and the signed cease and desist agreement.

Check in the amount of \$2,000.00 received on October 30, 2018, from David V. Vedral, License #9510, t/a Dave's Quality Electric, LLC, as the first and final payment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:5A-9(a).

The Board accepted the payment.

December 12, 2018

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Joseph Bello, Technical Educational Services, LLC, requesting approval of new courses and one new instructor.

Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, that a letter be sent to Mr. Clifford advising him that in order to regain his License #12830, he must take and pass the electrical contractors examination pursuant to N.J.A.C. 13:31-2.5(b). Mr. Clifford has not demonstrated hands-on experience since the time his Business Permit #12830 expired on March 31, 1997.

Mrs. Tucker stated that there is nothing to report to the Board.

The Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Fourteen (14) applications were approved.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
