E-mail dated December 2, 2014, received from Keith Smith, Subcode Official, Township of Piscataway, stating according to 5:23-2.15 a home owner can perform their own work in a single family dwelling. Mr. Smith also stated Article 100 in the National Electrical Code defines a single family dwelling as a building that consists solely of one dwelling unit. Therefore, Mr. Smith would like written clarification as to whether or not a homeowner can perform electrical work in a town house.

Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, that Deputy Attorney General Joseph Donofrio draft a letter to be sent to Mr. Smith advising him that the Board's statute deals with the ownership of a dwelling. Pursuant to N.J.S.A. 45:5A-9(n) work performed by a person on a dwelling that is occupied solely as a residence for himself or for a member or members of his immediate family is considered exempt from licensure and does not require the securing of a business permit.
