

889th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF
ELECTRICAL CONTRACTORS (PUBLIC SESSION) JULY 9 , 2014

The Board Minutes of July 9, 2014, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of September 3, 2014, or soon thereafter as it may be considered. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Board meeting of July 9, 2014, was called to order at 9:00 A.M.

David Freed, Acting Executive Director, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Senior Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, was present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

July 9, 2014

Joseph Donofrio, Deputy Attorney General, administered the oath swearing in Mr. Joseph P. Schooley and Mr. Gino Pasqualone as Board members.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (25) Initial Licenses effective July 9, 2014 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (22) Initial Business Permits effective July 9, 2014 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (5) Initial Business Permits Previously Expired effective July 9, 2014 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (6) of the (7) Changes in Business Permits effective July 9, 2014 to March 31, 2015. (Received e-mail on July 9, 2014, from Michael Gravatt requesting to withdraw his application for MAG Electric, LLC).

Pursuant to N.J.S.A. 45:5A-5 the Board shall elect a chairman to preside over the meetings and an Executive Director to serve the Board during the period of July 9, 2014 to June 30, 2015.

Mr. James H. Flaherty nominated Mr. Joseph P. Schooley, and the nomination was seconded by Mr. Constantinos Papademas.

Let the record reflect that Mr. Schooley has been elected Chairman for the Board from this date until the July 2015 meeting pursuant to N.J.S.A. 45:5A-5.

Mr. Joseph F. Cantalupo nominated David Freed, and the nomination was seconded by Mr. Constantinos Papademas.

July 9, 2014

Let the record reflect that Mr. Freed has been elected Acting Executive Director for the Board from this date until the July 2015 meeting pursuant to N.J.S.A. 45:5A-5.

Money Order in the amount of \$1,000.00 received from Brian Palaima, License #16047, t/a New Era Electric, as the first and final payment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-15.

The Board accepted the payment.

Cashier's Check in the amount of \$1,000.00 received from Ally Gibbs, Unlicensed, as the first installment of a civil penalty in the amount of \$1,080.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Additionally, Mr. Gibbs signed an agreement to cease and desist from engaging in the business of electrical contracting until such time as he becomes licensed. Balance due is \$80.00.

The Board accepted the payment.

The Board reviewed the application for Continuing Education Course/Seminar Approval received from Dwight C. Price, The Electrical Association of Philadelphia, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously approved, to approve three (3) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Salvatore Ferrara, Electrical Training Center, Inc, requesting approval of new courses.

July 9, 2014

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously approved, to approve one (1) new course and instructor. Mr. Ferrara will be reminded that licensed electrical contractors must attend all 30 hours in order to receive a certificate for the renewal of their license.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Sarah Barton, Warshauer Electric Supply, requesting approval of a new course.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously approved, to approve one (1) new course and instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Marilyn Becker, Samson Electrical Supply Company, Inc., requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously approved, to approve two (2) new courses and instructor.

Letter dated June 11, 2014, received from Rose Boyd, e-Hazard, requesting approval of a new course.

Ms. Boyd stated the course entitled "High Voltage Refresher" is not exactly the same as a previously approved course entitled "Electrical Workplace Safety NFPA 70E - Refresher". The approved instructor, Al Havens, advised he omitted a high voltage video and a few live line tool slides because the workers do not work on overhead lines. In its place, the instructor included some material from the approved "Low Voltage" course.

July 9, 2014

Ms. Boyd also requests that the Board allow licensees to receive retroactive credit for having already taken this course.

Motion made by Mr. Constantinos Papademas and seconded by Mr. James H. Flaherty, and unanimously passed, that a letter be sent to Ms. Boyd advising that her request to teach the course entitled "High Voltage Refresher" is not approved. Ms. Boyd will also be advised Continuing Education courses must be sent in by the Sponsor and pre-approved by the Board in order for the licensee to receive credit.

Additionally, the Board would like to know whether or not Merck employees were required to take this course; did e-Hazard represent to the individuals taking this course that they would receive credit for the renewal of their electrical contractor's license; and did e-Hazard issue Continuing Education Course certificates to the New Jersey licensed electrical contractors who attended this course?

Letter dated June 24, 2014, received from Larry Logan, Secretary, International Association of Electrical Inspectors, South Jersey Chapter, requesting approval to teach one hour continuing education courses to be held at regular meetings.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve Mr. Logan's request to teach one hour continuing education courses held at their regular meetings. Mr. Logan must abide by the following guidelines:

1. Speaker presentations must be a minimum of one hour.
2. One hour of credit will be granted per presentation at each regular association meeting.
3. A Board approved instructor must be present at the presentation and monitor attendees if the presenter is not currently Board approved.
4. Presentations of two hours or longer, or multiple presentations of one hour, at regular meetings need prior Board approval to receive more than one hour of credit.

July 9, 2014

5. Sponsor/Association shall maintain a listing of CE courses given at regular meetings with name of instructor(s) and resume(s) or brief bio, subject matter of course with a brief outline, and Board approved instructor(s) who monitored attendees.
6. Sponsor/Association must follow Mandatory Guidelines for Continuing Education Instructors established by the Board of Examiners of Electrical Contractors.
7. Sponsor/Association must submit to the Board biannually (January and July), course titles/outlines and resumes for the courses taught during each preceding six month period.

E-mail dated June 18, 2014, received from Michael T. Ireland, License #17482, stating his county has implemented a shared services program. Mr. Ireland also stated because he is employed by the county college, he is concerned that he may be requested to work outside of the college's property. Mr. Ireland asks whether or not he is allowed to perform work on county property through the shared services program.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Ireland asking whether or not the work is performed on county property; is he an employee of the county or of the college and is his W-2 income tax form issued by the county or by the college. Mr. Ireland will also be asked to provide a copy of the Shared Services Agreement.

Signed agreement received from Dominick Natoli and Stuart Perlman, Totally Basements, LLC, d/b/a The Basic Basement Company, agreeing to include in advertisements which incidentally advertise electrical contracting services the truthful disclaimer, or a statement of similar effect, "all electrical work performed by licensed electrical contractors".

The Board accepted the signed cease and desist agreements.

July 9, 2014

Signed acknowledgment received from Jean-Paul Modde, ex-CEO, The Solar Center, Inc., in response to a Uniform Penalty Letter sent to Richard Klein, Russell Diamond and John Bailey, Home Improvement Contractors Registration #13VH00874100 (Expired), who were found to be in violation of N.J.S.A. 45:5A-9.

Mr. Modde signed the acknowledgment on behalf of The Solar Center, Inc. acknowledging the conduct charged and agreeing to cease and desist from engaging in the business of electrical contracting in the State of New Jersey. Mr. Modde advised the business is closed.

The Board accepted the signed acknowledgment.

Letter dated June 10, 2014, received from Richard Goldbeck, License #6354 (Expired), stating he has been on assignment in Iraq and Afghanistan since 2009 serving as a military contractor supporting US military initiatives.

Mr. Goldbeck also stated he returned to the United States in December 2013, but was unable to attend continuing education courses immediately upon his return due to family issues. Mr. Goldbeck also stated he is now taking the required courses and requests an extension until August 30, 2014 in order to complete same.

At its July 11, 2012 meeting, the Board granted Mr. Goldbeck a six-month extension to complete the 34 hours of Continuing Education Courses for the 2012 triennial renewal period. The six-month extension will commence upon his return from assignment in Afghanistan.

Motion made by Mr. Constantinos Papademas and seconded by Mr. James H. Flaherty, and unanimously passed, that a letter be sent to Mr. Goldbeck granting him a six-month extension to complete the 34 hours of Continuing Education Courses for the 2012 triennial renewal period. The six-month extension will commence upon his return from his assignment in Afghanistan. Additionally, the Board determined Mr. Goldbeck will not be able to renew his business permit until such time as he returns from his assignment.

July 9, 2014

The Board reviewed applications for the written examination to be administered by Prometric. Nine (9) applications were approved.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
