September 2, 2015

The Committee unanimously recommended to approve (6) Initial Licenses effective September 2, 2015 to March 31, 2018.

The Committee unanimously recommended to approve (7) Initial Business Permits effective September 2, 2015 to March 31, 2018.

The Committee unanimously recommended to approve (9) Initial Business Permits Previously Expired effective September 2, 2015 to March 31, 2018.

The Committee unanimously recommended to approve (2) Changes in Business Permits effective September 2, 2015 to March 31, 2018.

The Committee reviewed an Application for Continuing Education Course/Seminar Approval received from Eric DeGesero, New Jersey Independent Electrical Contractors Association, requesting approval of new courses.

The Committee unanimously recommended to approve twenty-three (23) new courses and instructors.

\*\*\*\*\*

The Committee reviewed an Application for Continuing Education Course/Seminar Approval received from Richard F. Van Wert, Electric Education Center, requesting approval of new courses and a new instructor to teach previously approved courses.

The Committee unanimously recommended to approve thirteen (13) new courses and the previously approved nine hours of code changes and the one hour of Laws, Rules, and Regulations. The Committee also approved Mr. Van Wert's request to approve a new instructor to teach previously approved courses.

Letter dated August 3, 2015, received from Greg Chontow, New Jersey Chapter, International Association of Electrical Inspectors, requesting approval to teach courses previously approved under the sponsorship of the New Jersey Skyland Division.

Mr. Chontow also requested that the Board approve one hour of credit for courses to be taught at each regular meeting held by the New Jersey IAEI Chapter.

September 2, 2015

The committee unanimously recommended that the courses approved under the New Jersey Skyland Division's sponsorship can be taught under the New Jersey Chapter IAEI's sponsorship, upon receipt of a letter from the New Jersey Skylands Chapter permitting same. The Committee also approves Mr. Chontow's request to teach one hour continuing education courses to be held at regular meetings held by the IAEI - New Jersey Chapter.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from Sarah Barton, Warshauer Electric Supply.

The Committee unanimously recommended to approve one (1) new course and an instructor.

Let the record reflect Gino Pasqualone recused himself from the discussion and recommendation as he is a friend of Mr. Dominik.

Application for reinstatement received from Joseph Dominik, License #13990 (Inactive).

Office files reflect Mr. Dominik chose "Inactive" status on March 28, 2003. Business Permit #13990 expired on March 31, 2000.

The Committee unanimously recommended to reinstate Mr. Dominik's License #13990. Mr. Dominik has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement as he had been actively involved in the electrical field prior to his illness and is a Subcode Official.

The Committee reviewed an e-mail dated July 23, 2015, received from Chip Purcell, t/a Electric Man, LLC, stating he is the holder of an area franchise license agreement for Current Safe which performs non-destructive electrical hazard detection testing in existing residential and small commercial facilities. Mr. Purcell also stated the testing is done with infra-red cameras, ultrasonic monitoring, circuit analyzers, resistance meters and like equipment that interacts with, but does not modify, the existing electrical distribution system. The tests are able to reveal potential hazards behind the walls and make recommendations on how to remediate the hazards.

September 2, 2015

Mr. Purcell asked whether or not an electrical contractor's license is required to perform such work.

The Committee unanimously recommended to go into Executive Closed Session to receive advice of council.

After a brief discussion in Executive Closed Session, the Board returned to Public Session.

The Committee unanimously recommended that Mr. Purcell be requested to appear before the Board to clarify the work that is performed. The Committee does not have enough information to determine if the work falls within the scope of practice.

Letter dated March 17, 2015, received from Derek E. DiRocco, License #15148, t/a Priority Power Company, Inc., requesting an extension to complete his Continuing Education Courses required for the 2015 triennial renewal period.

Mr. DiRocco stated he is the sole care giver for his wife who was diagnosed with cancer in August 2014. Mr. DiRocco also stated he would have been able to complete his continuing education; however, her surgery was scheduled in March 2015.

The Committee unanimously recommended that Mr. DiRocco's request be held in abeyance pending receipt of a note from his wife's physician indicating that she is in need of constant care. Upon receipt of same, Mr. DiRocco will have until September 30, 2015 to take his courses.

In response to the Board's request, a letter dated July 8, 2015, was received from Mr. DiRocco stating his wife has been scheduled for an additional surgery which will require four to six weeks recovery time. Therefore, Mr. DiRocco is requesting an additional extension until November 30, 2015, to take his continuing education courses.

Mr. DiRocco provided a note from his wife's physician stating he is the sole caregiver.

September 2, 2015

The Committee unanimously recommended that a letter be sent to Mr. DiRocco advising him that his request is granted and he has until November 30, 2015 in which to take his courses. Mr. DiRocco will be requested to send copies of his certificates to the Board office.

Letter dated July 9, 2015, received from Donald A. Clare, Electrical Subcode Official, Township of Neptune, requesting clarification of the HVACR regulation under N.J.A.C. 13:31A-1.3 (a) (1) and (2) "Electrical Work" which states:

a) Except in replacement cases described in the definition of "heating, ventilating, air conditioning, and refrigeration," a master HVACR contractor shall not perform any electrical work:

1) With a potential of more than 10 volts, except as provided in (a)2 below;

or

2) With a potential of more than 30 volts, in class III structures, as defined by N.J.A.C. 5:23-1.4.

DAG Donofrio stated that the HVACR Board has addressed this issue and concluded that this work can be performed by an HVACR Contractor.

The Committee unanimously recommended that a letter be sent to Mr. Clare informing him that the Board is in agreement with the HVACR's recommendations and this work can be performed by an HVACR Contractor.

Letter dated July 24, 2015, received from Dennis DeAngelo, HVACR License #126, t/a Dennis DeAngelo Plumbing, Heating & Cooling, Inc., stating there is a gray area regarding work that HVACR contractors are allowed to perform in the installation of a new condenser unit and an existing unit.

This matter is being held in abeyance.

Assembly Bill A4333 was passed in the Senate on August 13, 2015. This bill exempts certain activities of alarm businesses from statutes governing the practice of locksmithing.

Ms. Widrich advised that she has nothing to report to the Board.

The Committee reviewed applications for the licensing examination to be administered by PSI Services, LLC. Seven (7) applications were approved.

The Committee unanimously recommended to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
