

911th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - OCTOBER 5, 2016

The Board Minutes of October 5, 2016, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of November 2, 2016, or soon thereafter as it may be considered. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Board meeting of October 5, 2016, was called to order at 9:00 A.M.

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Kerrie Shahan, Government Service Representative, was present from 9:00 A.M. until the close of the meeting.

The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve the Minutes of the 910th Open Session Business Meeting held September 7, 2016.

October 5, 2016

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (12) Initial Licenses which will expire on March 31, 2018. (Licenses were issued from August 30, 2016 through September 27, 2016).

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (8) Initial Business Permits which will expire on March 31, 2018. (Permits were issued from August 30, 2016 through September 30, 2016).

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (11) Initial Business Permits Previously Expired which will expire on March 31, 2018. (Permits were issued from September 9, 2016 through October 2, 2016).

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (12) Changes in Business Permits which will expire on March 31, 2018. (Permits were issued from August 30, 2016 through October 1, 2016).

Check in the amount of \$100.00 received from Michael C. Butler, License #16316, t/a New Jersey Electrical Services, LLC, as the first installment of a civil penalty in the amount of \$2,000.00 for violation of N.J.S.A. 45:51-21(e). Balance due is \$1,900.00.

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Kim Good, EC&M Workplace Learning Center, requesting approval of a new course.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve one (1) new course and an instructor. Ms. Good will be advised that this course cannot be taught until January 2017. Ms. Good will also be advised licensees attending this course will not receive credit for having attended the "Nine Hours of Code Changes and One Hour of Laws Rules and Regulations".

October 5, 2016

At its October 5, 2016 meeting, the Board reviewed an application for Continuing Education Course/Seminar Approval received from Eric DeGesero, New Jersey Independent Electrical Contractors (NJIEC), requesting approval of new courses.

As per the Board's request, Mr. DeGesero provided resumes for the new instructors listed on his application.

The Board voted to approve twenty (20) new courses and new instructors.

At its September 7, 2016 meeting, the Board reviewed an application for Continuing Education Course/Seminar Approval received from Joanne Vander Kooy, National Technology Transfer, requesting approval of new courses and new instructors to teach previously approved courses (updating the "2014 National Electrical Code" to the "2017 National Electrical Code"). Ms. Vander Kooy's request was held in abeyance pending further review.

The Board voted to approve six (6) new courses and instructors, and new instructors to teach previously approved courses. Ms. Vander Kooy will be advised that the approved courses (excluding the course entitled "Hydraulics and System Troubleshooting") are not to be taught until January 2017. Ms. Vander Kooy will also be advised that Licensed Electrical Contractors must attend all 16, 24 and 32 hours in order to receive a certificate for the renewal of their license.

At its September 7, 2016 meeting, the Board reviewed an application for Continuing Education Course/Seminar Approval received from Elizabeth Woodstock, IEC Chesapeake, requesting approval of new courses. Ms. Woodstock's request was held in abeyance as courses involving the 2017 Code Changes cannot be taught until after January 2017.

The Board determined that the courses entitled "2017 Changes to the NEC" and "Grounding & Bonding Changes 2017" are approved along with the instructors; however, the courses cannot be taught until January 2017.

October 5, 2016

At its September 7, 2016 meeting, the Board reviewed an application for reinstatement of a license received from Anthony Della Serra, Jr.

Office files reflect Mr. Della Serra's License #14321 expired on March 31, 2012.

As per the Board's request, Mr. Della Serra provided a Work Experience Certification completed by his current employer and a copy of his Continuing Education Course certificate reflecting he attended the Nine Hours of Code Changes and One Hour of Laws, Rules and Regulations. Mr. Della Serra also provided copies of sign in/sign out sheets showing that he attended 24 hours of Continuing Education Courses.

The Board voted to reinstate Mr. Della Serra's License #14321 as he has demonstrated to the Board's satisfaction that he meets the requirement for reinstatement.

The Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Fifteen (15) applications were approved.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
