The Board saluted the Flag.

December 2, 2015

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (2) Initial Licenses effective December 2, 2015 to March 31, 2018.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (5) Initial Business Permits effective December 2, 2015 to March 31, 2018.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (8) Initial Business Permits Previously Expired effective December 2, 2015 to March 31, 2018.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (7) Changes in Business Permits effective December 2, 2015 to March 31, 2018.

The Minutes of the 902nd Open Session Committee Meeting held October 4, 2015, were not ready for Board approval.

Check and Postal Money Order in the amount of \$100.00 each received from Christian F. Rupp, IV, License #8149, t/a CR Electrical Contracting, as the twenty-third and twenty-fourth (final) installments of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dennis Campbell, Comprehensive Education Solutions, LLC, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve two (2) new courses and an instructor. Mr. Campbell will be advised that no substitutions will be allowed as noted in his course outline entitled "OSHA 10 Hour Construction".

December 2, 2015

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter NECA, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve seven (7) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Joseph J. Bello, Technical Educational Services, LLC, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve four (4) new courses and instructors and previously approved courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dennis Kennedy, M Davis, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve three (3) new courses and an instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Bruce M. Rockwell, P.E., American Electrical Testing Co. Inc, requesting approval of new courses.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve one (1) new course and an instructor.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Eric DeGesero, New Jersey Independent Electrical Contractors, requesting approval of new courses.

December 2, 2015

Motion made by Mr. Constantinos Papademas and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve two (2) new courses and instructors.

Letter dated November 4, 2015, received from Pamela G. Frank, VP, Gabel Associates, requesting the Board consider a regulation which would allow a qualified representative to submit permits on behalf of the licensed electrical contractor.

DAG Donofrio stated he, Ms. Frank and Deputy Director Howard Pine, had a telephone conference. Ms. Frank is asking that the Board consider a regulation that would allow licensees to authorize an employee to obtain permits.

Mr. Schooley stated as long as the permit application is completed, signed, and sealed by the electrical contractor, it does not matter who physically delivers the permit application to the township construction office. The permit application can also be mailed to the construction office.

Mr. Flaherty stated the Board has had many complaints involving work that had been performed without the licensee's knowledge or signature on the permit application.

E-mail received from Dominique Tomlinson, At Your Pace Online, LLC, requesting approval to teach on-line continuing education courses. Ms. Tomlinson stated the company will offer a safe, convenient, and cost-effective online format to licensees while ensuring student/licensee accountability and course mastery.

After briefly discussing Ms. Tomlinson's request, the Board suggested that this matter be discussed at a future Board meeting.

An Administrative Action Consent Order filed on August 15, 2013, by the Division of Consumer Affairs, ordered that Kenneth Garrigan, Unlicensed, d/b/a Big K Home Repair & Contracting, shall pay a civil penalty in the amount of \$2,500.00 and costs in the amount of \$1,500.00 to the Office of Consumer Protection; pay a civil penalty in the amount of \$2,500.00 and costs in the amount of \$150.00 to the Board of Master Plumbers; pay a civil penalty in the amount of \$3,000.00 and costs in the amount of \$150.00 to the Board of Electrical Contractors. Mr. Garrigan was found to be in violation of N.J.S.A. 56:8.1, N.J.S.A. 56:8-126, N.J.A.C. 13:45A-9.1, and N.J.A.C. 13:45A-16.1.

December 2, 2015

This matter is considered closed.

William B. Sinclair, License #15270, has failed to respond to a Provisional Order of Discipline filed May 14, 2015, ordering he pay a civil penalty in the amount of \$10,000.00 for violation of N.J.A.C. 13:45C-1.2 and License and Business Permit #15270 be suspended until such time as he appears before the Board.

This matter is being held in abeyance pending receipt of a signed certified card showing receipt of the POD.

Ms. Tucker stated that there is nothing to report to the Board.

The Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Eleven (11) applications were approved.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
