

**805 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS  
(PUBLIC SESSION) - - - JANUARY 3, 2007**

Minutes of January 3, 2007, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of February 7, 2007. All requirements of the Open Public Meetings Act have been complied with according to N.J.S.A. 10:4-6.

Meeting of January 3, 2007, was called to order at 9:00 A.M.

The Board saluted the Flag.

Mr. Robert A. McCullough abstained from the following motion.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and passed, to approve the Minutes of the 804 Meeting held December 6, 2006 with the following corrections:

Page 4, Paragraph 1

Mr. Constantinos Papademas recused himself from the motion concerning Dorothy Adlon's request to teach

continuing education courses as he is the instructor who will be teaching those courses.

Page 6, Paragraph 4

Mr. Aicher stated that it is not fair to the licensed electrical contractors who may have to pay higher licensing fees because the Board is spending money trying to locate unlicensed individuals.

Page 6, Paragraph 10

Ms. Kane stated that the Board should be consistent in the amount of civil penalties assessed. The Board must separate the penalties assessed from its costs as the Board can collect monies expended for Enforcement Bureau activity. If the Board is charged \$1,000.00 by the Enforcement Bureau to locate an individual, or is charged for the appearance of the court reporter and for the transcript that has been ordered, the Board can then incorporate those costs onto the unlicensed individual when preparing a settlement offer.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (10) Initial Licenses effective January 3, 2007, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (10) Initial Business Permits effective January 3, 2007 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (6) Initial Business Permits Previously Expired effective January 3, 2007 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (6) Changes in Business Permits effective January 3, 2007 to March 31, 2009.

Check in the amount of \$100.00 received from Michael Delli Santi, Unlicensed, as the thirteenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 29, 2005 and the balance due is \$1,100.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Nick Ortense, Unlicensed, as the fifteenth installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 18, 2005 and the balance due is \$600.00.

The Board accepted the payment.

Checks in the amount of \$50.00 each received from Vernon Walderon, Unlicensed, as the sixth and seventh installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9(a) and N.J.S.A. 56:8-1 et seq. Payments started July 17, 2006 and the balance due is \$200.00.

The Board accepted the payment.

The Board reviewed an Application for Reinstatement received from Thomas G. Tait as he failed to renew his

License #11801 for the 1997 to 2000; 2000 to 2003; 2003 to 2006 and 2006 to 2009 triennial renewal periods.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Tait advising him that he must take and pass the written examination in order to regain his license pursuant to N.J.S.A. 45:1-7.1(d).

Letter dated October 27, 2006, received from Robert C. Anderson, License #5240 (Expired) appealing the Board's decision that he must take and pass the electrical contractor's examination in order to regain his License #5240 which Mr. Anderson failed to renew for the 1997 to 2000; 2000 to 2003; and 2003 to 2006 triennial renewal periods.

Mr. Anderson was previously advised that it did not appear that his reasons for not renewing were due to severe illness, disability, or military service. Mr. Anderson was also advised that the Board must abide by N.J.A.C. 13:31-2.3 (c) which stipulates that five years after a license has expired a licensee is not permitted to renew his/her license without first taking the qualifying examination.

At its meeting held November 1, 2006, the Board requested that Deputy Attorney General Ginger R. Provost prepare a Provisional Order of Denial to be sent to Mr. Anderson denying his request to be issued his License #5240 without first passing the electrical contractor's examination.

DAG Provost requested that this matter be presented to the Board for reconsideration based on Mr. Anderson's October 8, 2006 letter.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Anderson advising him that he must take and pass the written examination in order to regain his license pursuant to N.J.S.A. 45:1-7.1(d).

\*\*\*\*\*

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Marcel Renson. Mr. Renson was requested to provide a more detailed course outline for the courses entitled "National Electrical Code and The Energy Subcode"; "Rehab Subcode and The National Electrical Code"; "Article 555 Marinas and Boatyards" and "Introduction to the Uniform Construction Code".

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (4) new courses, and instructor, are approved as submitted.

The sub-committee reviewed a letter dated September 28, 2006, received from members of the New Jersey Contractors Educational Institute, Inc. concerning the denial of computer based courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to the New Jersey Contractors Educational Institute, Inc. reaffirming the Board's decision to deny the computer courses as they are not related to the electrical industry and do not meet the criteria of continuing education pursuant to N.J.A.C. 13:31-1.7.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Christina Bailey.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed,

that a letter be sent to Ms. Bailey advising her that the course entitled "2005 National Electrical Code" is being denied. The course description indicates that the students will have the opportunity to answer typical licensing examination questions. However, as continuing education is for licensed electrical contractors, this portion of the class cannot be part of the instructional hours.

Ms. Bailey may resubmit an outline based solely on the "2005 National Electrical Code". The course entitled "Boiler Operation, Maintenance & Safety" is denied as it does not relate to the field of electrical contracting. The course entitled "Basic Electricity for the Non-Electrician" is denied as it does not appear to be a course for licensed electrical contractors. The course entitled "Electrical Troubleshooting & Preventive Maintenance" is denied as this course does not meet the criteria of continuing education.

\*\*\*\*\*

The Board reviewed an E-Mail dated September 18, 2006, which was forwarded by the Governor's Office received from Michael S. Shor requesting that the Board allow individuals, who are not licensed electrical contractors, to install central vac, sound and security systems. Mr. Shor stated that these systems are 24 volt DC systems.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Shor advising him that the legislature has mandated by Statute N.J.S.A. 45:5A-18. Therefore, his request to change the exemption is not within the Board's jurisdiction.

\*\*\*\*\*

The Board reviewed the proposed repeals of several rules because the time has expired for applicants for licensure to avail themselves of the grandfathering or waiver of examination options. N.J.A.C. 13:31A-2.2 sets forth the grandfathering option for licensure as a locksmith and provides that an applicant for a locksmith license who applies prior to September 15, 2004 shall be granted a license if he or she satisfies the requirements set forth in the rules. N.J.A.C. 13:31A-2.3 and 3.3 provides for a waiver of the locksmith or alarm examination, respectively, for applicants who satisfy the requirements of the rules and who apply by July 13, 2004.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board approves the action taken by the Fire Alarm, Burglar Alarm, Locksmith Advisory Committee to repeal N.J.A.C. 13:31A-2.2, N.J.A.C. 13:31A-2.3, and N.J.A.C. 13:31A-3.3.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirty-five (35) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
