

**806 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS
(PUBLIC SESSION) - - - FEBRUARY 7, 2007**

The Board Minutes of February 7, 2007, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of March 7, 2007. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Meeting of February 7, 2007, was called to order at 9:00 A.M. The following members were present:

Ginger R. Provost, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was James Bibbo, Central Jersey Electrical League.

The Board saluted the Flag.

***** Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 805 Meeting held January 3, 2007, with two corrections in Closed Session.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Richard T. Aicher, Jr. and unanimously passed, to approve (13) Initial Licenses effective February 7, 2007 to March 31, 2009.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Richard T. Aicher, Jr. and unanimously passed, to approve (23) Initial Business Permits effective February 7, 2007 to March 31, 2009.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Richard T. Aicher, Jr. and unanimously passed, to approve (6) Initial Business Permits Previously Expired effective February 7, 2007 to March 31, 2009.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Richard T. Aicher, Jr. and unanimously passed, to approve (6) Changes in Business Permits effective February 7, 2007 to March 31, 2009.

Check in the amount of \$50.00 received from Vernon Walderon, Unlicensed, as the eighth installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started July 17, 2006 and the balance due is \$100.00.

The Board accepted the payment.

Check in the amount of \$100.00 received from Michael Delli Santi, Unlicensed, as the fourteenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 29, 2005 and the balance due is \$1,000.00.

The Board accepted the payment.

Check in the amount of \$25.00 received from Nick Ortense, Unlicensed, as the sixteenth installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 18, 2005 and the balance due is \$575.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Casey Morton, License #15756, as the tenth and final installment of a civil penalty in the amount of \$6,000.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Checks in the amounts of \$500.00 each received from George Piper, License #8302 as the first and second (final) installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-15.

The Board accepted the payment.

Letter dated January 3, 2007, received from Joan Hazuka requesting a six-month continuance of business under permit #7644 according to N.J.S.A. 45:5A-14. The licensee Edward P. Hazuka, Jr., died on December 22, 2006.

Mrs. Hazuka stated that Edward Von Dettum, an employee of 17 years, will be responsible for completing all outstanding projects.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Van Dettum advising him that the Board has granted the firm of Hazuka Electric, Inc. a six-month continuance of Business Permit #7644 according to N.J.S.A. 45:5A-14.

Letter dated February 5, 2007, received from Lawrence Demetris, President, Tri-State Fire & Electrical Services, Inc., requesting a six-month continuance of business under permit #14957. Mr. Demetris stated that the licensee who endorsed his business permit to the company has left.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Constantinos Papademas, and unanimously passed, that letter be sent to Mr. Demetris advising him that the Board has denied his request to be granted a six-month continuance of business as his reason does not meet the conditions as set forth in N.J.A.C. 13:31-3.3(d).

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Bernadette Berger, Technical Educational Services.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (8) new courses, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Thomas McNulty, National Electrical Contractors Association.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (4) new courses, and instructors, are approved as submitted.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Thomas Valeo.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that (5) new courses, and instructor, are approved as submitted. Mr. Valeo will be sent a letter asking him if the instructors mentioned in his application will also be teaching the approved courses. If so, which courses will they be teaching.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Victor V. Timpanaro, Municipal Electrical Inspectors Association of New Jersey, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Robert A. McCullough, and unanimously passed, that (3) new courses, and instructors, are approved as submitted.

Mr. Mitchell R. Malec abstained from the following motion as he is a government representative and Mr. Robert A. McCullough abstained from the following motion as he is one of the instructors who will be teaching the courses being presented to the sub-committee.

The sub-committee reviewed a revised application for Continuing Education Course/Seminar approval received from Susan McLaughlin, New Jersey Department of Community Affairs/Rutgers University. Ms. McLaughlin was requested to complete a new application and provide a more detailed course outline for the courses submitted and the names of individual instructors teaching these courses.

The Board approved Ms. McLaughlin's request to teach (22) new courses as resubmitted. The instructors are also approved.

Letter dated January 16, 2007, received from Roger Simonds, Executive Director, National Electrical Contractors Association, concerning the installation of Solar Photovoltaic Array Modular Panels which emit a voltage greater than ten volts when subjected to natural or artificial light. Mr. Simonds stated that the panels are being installed by unlicensed individuals.

Mr. McCullough stated that the panel has an opaque covering which is pre-done at the factory with matching modular connections and at the end of the array, there is the connection that the licensed electrical contractor performs. Mr. McCullough also stated that the grounding and bonding is performed by the electrical contractor after the carpenter bolts the panels to the roof. Mr. McCullough further stated that in his opinion an electrical contractor does not have to install the panels on the roof.

Mr. Papademas stated that it is his opinion that if it is an electrical piece of equipment, that equipment should be installed by a licensed electrical contractor.

Mr. Flaherty stated what about the modular's that are built right into the roof shingles?

This matter is being held in abeyance and will again be discussed at the March 2007 meeting.

The Board reviewed Assembly Bill No. 3899 which clarifies the requirement that a public body make its minutes "promptly available" to the public following a meeting pursuant to the "Senator Byron M. Baer Open Public Meetings Act." Under the bill, a public body would have until noon on the 30th day following the meeting at which the minutes were taken to make the minutes of the public portions of the meeting available to the public. If the public body failed to comply with this requirement and a member of the public is forced to go to the court for injunctive relief or other remedy, the court would be required to award reasonable attorney fees and court costs incurred by the person.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the Board opposes Assembly Bill No. 3899 as written. It is the opinion of the Board that the Open Session Minutes of the Meetings be made public 30 days from final Board approval.

Signed cease and desist agreements were received from Thomas Ciccarelli, Middletown, New Jersey; Richard

Boyle, t/a Residential Wiring; Luis Gomez, Dover, New Jersey; Edward Lawless, Somers Point, New Jersey; Jose Andrade, Kearny, New Jersey; and Ro-Mike Handyman's Network, LLC, Glen Rock, New Jersey.

The Board accepted the signed cease and desist agreements.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Eight (8) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Robert A. McCullough, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
