Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve the Minutes of the 839<sup>TH</sup> Open Session Business Meeting held January 6, 2010.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (29) Initial Licenses effective March 3, 2010 to March 31, 2012.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (23) Initial Business Permits effective March 3, 2010 to March 31, 2012.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (4) Initial Business Permits Previously Expired effective March 3, 2010 to March 31, 2012.

The Board discussed the possibility of including language in all future penalties that would stipulate if a penalty was not paid within one years time, an administrative fee of \$200.00 would be assessed.

March 3, 2010

Letter dated February 16, 2010, received from Michael Anzaldo, License #5834, requesting a six-month continuance of business under Permit #4972 according to N.J.S.A. 45:5A-14. The licensee, William R. Sefchick, died on November 7, 2009.

Mr. Anzaldo stated that he is completing the paperwork in order to endorse his license to Sef An Electric, Inc.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Anzaldo advising him that pursuant to N.J.S.A. 45:5A-14 the firm of Sef An Electric, Inc. has been granted a six-month continuance of business under permit #4972. The extension will expire on May 7, 2010.

Letter dated February 23, 2010, received from James J. White, IV, President, JJ White Inc. requesting a third six-month continuance of business under Permit #3256 according to N.J.S.A. 45:5A-14. The licensee, John E. White, died on March 9, 2009.

The first and second extension expired on March 29, 2010.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. White advising him that his request to be granted a third continuance of business under permit #3256 is denied. Mr. White will also be advised that should he choose to continue the business, he should make arrangements with a licensed electrical contractor, with a business permit, to complete any unfinished jobs after the extension expires on March 29, 2010. A second option would be to hire a licensed electrical contractor to endorse his/her business permit to the company.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Robert J. Sheridan.

At its December 2, 2009 meeting, the Board requested that Mr. Sheridan be advised that breaks and lunches cannot be included in the instructional hours. Therefore, Mr. Sheridan was to inform the Board if his courses would be two hours or three hours in length.

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter NECA.

Flaherty, and unanimously passed, that a letter be sent to Mr. McNulty advising him that his request to teach continuing education courses is denied. It is the opinion of the Board that building energy requirements are not beneficial to electrical contractors. Mr. McNulty will be requested to provide a more detailed outline and breakdown of each topic.

At its March 4, 2009 meeting, the Board reviewed a letter from John F. Grillo, License #3242, t/a John Grillo Electrical Contractor, requesting an extension to complete his Continuing Education Courses for the 2009 to 2012 renewal period. Mr. Grillo had been hospitalized for emergency surgery and was granted an additional six months to complete his Continuing Education Courses.

Letter received on November 16, 2009, from Mr. Grillo stating that he has been unable to locate a sponsor teaching the nine hours of code changes and one hour of laws, rules and regulations. Mr. Grillo provide copies of Continuing Education Course certificates for the courses he has attended.

March 3, 2010

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Grillo advising him that his request is denied. Mr. Grillo will be granted an additional two months in which to complete his Continuing Education Courses.

The Board reviewed the first half of the Fiscal Year 2010 Budget report.

The Board requested that Karlene Kane appear before it to discuss the line item regarding the scanning of documents.

E-Mail received from Richard Diaz, Master Plumber's License #11239, asking why a licensed electrical contractor is required to connect two wires and a ground from the disconnect box to the new HVAC condensing unit being installed. Mr. Diaz also stated that licensed master plumbers should be able to connect a new condenser to the existing electric disconnect box.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Diaz advising him that the law does not permit plumbers to wire HVAC units, condensing units, and electric hot water heaters. The Board does not consider this work of a similar nature.

Letter dated February 3, 2010, received from Dennis A. Maycher, Esq., on behalf of T & R Alarm Systems, Inc., in response to a notice sent by the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee. The notice advises T & R Alarm Systems, Inc. that the Committee's records do not reflect that the business is licensed.

Mr. Maycher stated that Thomas A. Sansone is the licensee of T & R Alarm Systems, Inc. Therefore, he is in compliance with the law and is not required to either cease alarm services or obtain an additional license.

Office files reflect that License and Business Permit #6580 were issued to Thomas A. Sansone, T & R Electric, Division of T & R Alarm Systems, Inc.

Office files also reflect that a letter dated March 27, 2007, was received from Mr. Sansone asking whether or not, as an electrical contractor, is he required to obtain a separate alarm license.

A letter dated May 4, 2007, was sent to Mr. Sansone advising him that he is exempt from having to obtain a burglar or fire alarm license to engage in the alarm business as he is a New Jersey Licensed Electrical Contractor, who holds a business permit, pursuant to N.J.S.A. 45:5A-29(b).

March 3, 2010

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Maycher reiterating that he is exempt from having to obtain a burglar or fire alarm license to engage in the alarm business as he is a New Jersey Licensed Electrical Contractor, who holds a business permit, pursuant to N.J.S.A. 45:5A-29(b). Mr. Maycher will be reminded to advertise his full business name on all forms of advertising pursuant to N.J.A.C. 13:31-1.5.

The Board review applications for the written examination to be administered by Thomson Prometric. Fourteen (14) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. James H. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
