

875th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - MARCH 6, 2013

The Committee Minutes of March 6, 2013, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of April 3, 2013, or soon thereafter as it may be considered.

All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6. The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Committee meeting of March 6, 2013, was called to order at 9:00 A.M.

David Freed, Acting Executive Director, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant 3, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was Robert Spellman, Electrical Contractors Association of New Jersey.

The Committee saluted the Flag.

March 6, 2013

Note: A quorum was not present. All actions are to be ratified at the Board's next meeting to be held on March 6, 2013, or soon thereafter.

The Committee unanimously recommended to approve (33) Initial Licenses effective March 6, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (31) Initial Business Permits effective March 6, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (6) Initial Business Permits Previously Expired effective March 6, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (12) Changes in Business Permits effective March 6, 2013 to March 31, 2015.

The Committee unanimously recommended to approve the Minutes of the 873rd Open Session Business Meeting held January 9, 2013 with the following corrections.

Page 4, Paragraph 9

Mr. Schooley stated that he would like the Board to comment on the proposed regulation amending N.J.A.C. 5:23-2.7.

Mr. Malec abstained from the discussion and motion concerning the proposed amendment to N.J.A.C. 5:23-2.7.

The Committee unanimously recommended to ratify the Committee's recommendations for the Minutes of the 874th Open Session Committee Meeting held February 6, 2013.

March 6, 2013

Check in the amount of \$100.00 received from Christian Rupp, License #8149, t/a C R Electrical Contracting, as the fifth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$2,200.00.

The Committee unanimously recommended to accept the payment.

Check in the amount of \$200.00 received from Robert T. Brown, License #10584, t/a R T Brown Electrical Contracting, Inc., as the fifth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-13.1 et seq.; N.J.S.A. 45:1-21(h); N.J.A.C. 13:31-1.7(b & c). Payments started November 14, 2012 and the balance due is \$1,500.00.

The Committee unanimously recommended to accept the payment.

Mr. Constantinos Papademas recused himself from the motion and the discussion as he is listed as one of the instructors.

Mr. Malec stated for the record that he is an employee of the Department of Community Affairs; however, he does not have any conflict of interest.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from John Delesandro, NJ Department of Community Affairs/Rutgers University, requesting approval of new courses and previously approved courses.

The Committee unanimously recommended to approve fifteen (15) new courses, including two (2) hour Webinar courses, instructors, and previously approved courses and instructors.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from Victor V. Timpanaro, Technical Seminars, LLC, requesting approval of new courses and previously approved courses.

March 6, 2013

The Committee unanimously recommended that Mr. Timpanaro's request be held in abeyance. Mr. Timpanaro will be sent a letter requesting a more detailed course outline.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from Benedict J. Shedlock requesting that Colin Hylton be approved to teach previously approved courses.

The Committee unanimously recommended to approve Mr. Shedlock's request to approve Colin Hylton to teach previously approved courses.

Response received from Gary Nowicki, License #6808, to the Provisional Order of Discipline ordering that Mr. Nowicki is provisionally reprimanded and assessed a civil penalty in the amount of \$537.50 for violation of N.J.A.C. 13:31-1.7(b) and N.J.S.A. 45:5A-9.

This matter is being held in abeyance and will be discussed at the Board's April 3, 2013 meeting.

Letter dated November 25, 2012, received from Robert Saganski, License #4254, to the Provisional Order of Discipline filed on November 7, 2012, ordering that Mr. Saganski pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2. Additionally, Mr. Saganski's License and Business Permit #4254 were to be provisionally suspended until such time as he responds to the Board.

This matter is being held in abeyance and will be discussed at the Board's April 3, 2013 meeting.

This matter was reviewed by the Committee on February 6, 2013.

Letter dated June 14, 2012, received from Michael J. Revness, Esq., Kurtz & Revness, P.C., on behalf of John P. Cioffi who has applied to the Board to take the electrical contractors examination. Mr. Cioffi was sent a letter disapproving his application as it did not appear that he has five years of experience in compliance with the National Electrical Code.

March 6, 2013

The Board directed that Deputy Attorney General Joseph Donofrio draft a letter to be sent to Mr. Revness advising him that based on the application for examination submitted by Mr. Cioffi it does not appear that he has five years of experience in compliance with the National Electrical Code. Mr. Cioffi's hands on experience appears to be low voltage wiring.

Letter dated November 27, 2012, sent to Mr. Revness advising him that Mr. Cioffi's application for examination is disapproved as he did not possess the requisite experience requirements pursuant to N.J.S.A. 45:5A-9(b) and N.J.A.C. 13:31-2.1(a) (3).

Letter dated January 10, 2013, was received from Michael J. Revness, Esq., Kurtz & Revness, P.C., requesting that the full Board review this matter.

This matter is being held in abeyance and will be discussed at the Board's April 3, 2013 meeting.

E-Mail dated February 25, 2013, received from Jeffrey Hitchcock asking whether or not an electrical contractors license and business permit is required for a New Jersey project that involves battery and signal work within Sprint owned equipment and lease space at communication towers.

The Committee unanimously recommended that Deputy Attorney General Joseph Donofrio research whether or not Sprint is considered a public utility.

Should Sprint be considered a public utility, then it is the opinion of the Committee that such work shall not be included within the business of electrical contracting and not require the securing of a business permit pursuant to N.J.S.A. 45:5A-18(f).

Letter dated March 1, 2013, received from Peter A. Urbano, Jr., requesting a six-month continuance of business under Permit #6664 according to N.J.S.A. 45:5A-14. The licensee, Peter A. Urbano, Sr, died on December 7, 2012.

Peter A. Urbano, Jr., License #16303 requests approval to qualify the business for the six-month period.

March 6, 2013

The Committee unanimously recommended that pursuant to N.J.S.A. 45:5A-14 the firm of Urbano Electric Electrical Contractor has been granted a six-month continuance of business under permit #6664. The Board approves Peter A. Urbano, Jr., License #16303, to qualify the business for the six-month period.

Mr. Malec stated that the Department of Community Affairs is an approved sponsor for Continuing Education. Mr. Malec also stated that he would like to discuss whether or not blanket approval can be given to the Department of Community Affairs so that they may be able to offer electrical technical courses to licensed electrical contractors without first receiving approval by the Board.

Mr. Malec further stated that many electrical inspectors also hold electrical contractors licenses and would like to receive credit for attending a course for the renewal of their electrical contractor's license.

This matter is being held in abeyance to be discussed by the full Board.

Charles Manning, Regulatory Analyst, appeared before the Committee to discuss the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee adoption notice for Continuing Education Regulations.

Mr. Malec stated that he disagrees with the Committee's response that there is enough change to warrant two hours of continuing education in Barrier Free Subcode; New Jersey Uniform Construction Code; American with Disabilities Act Code; Industrial Safety; and Laws and Rules governing the provision of Burglar Alarm, Fire Alarm and Locksmithing Services. Mr. Malec also that there are not enough changes that would warrant two hours of continuing education and would like the comment to reflect that the Committee will explore whether or not two credits in each topic is warranted.

Mr. Malec stated he also disagrees with the Committee's response that it has determined continuing education requirements for fire alarm business qualifiers registered with the Department of Community Affairs are not substantially similar to N.J.A.C. 13:31A-1.12.

March 6, 2013

Mr. Manning stated that the commenter felt that all courses should be automatically approved without committee review. Mr. Manning also stated that the Committee did not have enough confidence that the Department of Community Affairs would provide courses that were of the same standard.

Mr. Malec stated that he agrees with the comment requesting that the language in N.J.A.C. 13:31A-1.16(d) be clarified to reflect that a business cannot operate without a business qualifier for more than one year.

Mr. Manning stated that he will meet with the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee to discuss these concerns.

The Board review applications for the written examination to be administered by Thomson Prometric. Twenty-six (26) applications were approved.

The Committee unanimously recommended to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
