Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was Joseph McMullen and Arnie Fletcher, Electrical Contractors Association of New Jersey.

The Board saluted the Flag.	

Motion made by Mr. Constantinos Papademas and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve the Minutes of the 861st Open Session Business Meeting held December 7, 2011, with the following corrections:

Page 2, Paragraph 6

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructor. Mr. DeBouter will be advised that the Board is only approving twenty-one (21) hours of the forty (40) hour course. Licensed electrical contractors must attend all 40 hours in order to receive a certificate for the renewal of their license. It is the Board's recommendation that the IBEW include this language in their advertisements.

Page 6, Paragraph 7

A Provisional Order of Discipline filed September 7, 2011, ordered Anthony J. Catalano, License #7623, to pay a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9; Mr. Catalano's License and Business Permit #7623 are provisionally suspended as a disciplinary action; and Mr. Catalano is provisionally reprimanded for having violated N.J.S.A. 45:1-21(h) and N.J.S.A. 45:1-21(n).

Page 6, Paragraph 8

In November 2011 Mr. Catalano paid his first penalty installment in the amount of \$100.00 (sentence to be deleted).

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve the Minutes of the 862nd Open Session Business Meeting held January 4, 2012.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to ratify the Committee's recommendations for the Minutes of the 863rd Open Session Business Meeting held February 1, 2012, with the following corrections:

Page 1, last paragraph

Note: A quorum was not present. However, Mr. Schooley participated by telephone on certain matters. Actions not ratified during this meeting are to be ratified at the Board's next meeting to be held on March 7, 2012, or soon thereafter.

Page 3, Paragraph 10

The word maximum is misspelled.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (27) Initial Licenses effective March 7, 2012 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (30) Initial Business Permits effective March 7, 2012 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (7) Initial Business Permits Previously Expired effective March 7, 2012 to March 31, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (20) Change in Business Permits effective March 7, 2012 to March 31, 2015.

At its December 7, 2011 meeting, the Board held in abeyance the issuance of an Initial Business Permit to A&E Factory Services, LLC pending receipt of additional information.

To date, a response has not been received.

The Board accepted the payment.

Cashier's Check in the amount of \$3,350.00 received from William H. Neimann, License #9222, as the first and final payment of a civil penalty in the amount of \$3,350.00 for violation of N.J.A.C. 13:31-1.7(a, b, c, & f) and N.J.S.A. 45:5A-13.1.

The Board accepted the payment.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Anthony T. Urbanik.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve ten (10) new courses and instructors and previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Eric J. Sivertsen, Northern New Jersey Chapter, Inc., NECA.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve previously approved courses and instructors.

Mr. Mitchell R. Malec abstained from the following discussion and motion as he is a representative of the Department of Community Affairs.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from John Delesandro, NJ Department of Community Affairs/Rutgers University.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Richard T. Aicher, Jr., and passed, to approve previously approved courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval for the 2015 triennial renewal period received from Salvatore Ferrara, Electrical Training Center, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructors, and previously approved courses and instructors.

Mr. Constantinos Papademas abstained from the following discussion and motion as he is listed as one of the instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Kennie M. Fried, Warshauer Electric Supply.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and passed, to approve two (2) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dessie Kirilova, Krannich Solar.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve two (2) new courses and instructors. These courses are approved as seven (7) hour courses and not eight (8) hour courses as the Board does not approve half hour courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Harry E. Smith, III, Certified Health and Safety Services, LLC.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructor. This course is approved as a five (5) hour course and not a six (6) hour course as the Board does not allow a quiz/exam to be part of the instructional hours and should not be a requirement in order for the licensee to receive a certificate.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Joseph Freeman, South Jersey Electrical Inspectors Association. Mr. Freeman is requesting that previously approved courses under the former sponsorship of MEIA South Jersey be transferred to the new sponsorship of South Jersey Electrical Inspectors Association.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Freeman's request be held in abeyance pending receipt of a request on South Jersey Electrical Inspector's letterhead and a listing of the courses the four new instructors will be teaching.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Nicola Donaven, American Trainco. Ms. Donaven was advised that her request was being held in abeyance as all instructors are not qualified to teach all three courses.

Ms. Donaven provided a listing of the instructors and the courses they are teaching.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve three (3) new courses and instructors as amended.

Letter dated February 15, 2012, received from Douglas S. Robinson, Instructor #837, requesting 10 hours of credit towards the renewal of his License #10088 pursuant to N.J.A.C. 13:31-1.7. Mr. Robinson has provided copies of attendance certification sheets reflecting that he has taught 10 hours of continuing education courses (nine hours of code changes and the one hour of laws, rules and regulations).

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Robinson be granted 10 credits toward his 2012 triennial license renewal.

Letter dated February 16, 2012, received from Arnold Olender, Instructor #672, requesting 15 hours of credit towards the renewal of his License #14146 pursuant to N.J.A.C. 13:31-1.7. Mr. Olender has provided copies of attendance certification sheets reflecting that he has taught 18 hours of continuing education courses which includes the nine hours of code changes and the one hour of laws, rules and regulations.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Olender be granted 15 credits toward his 2012 triennial license renewal.

Letter received February 21, 2012, from Lawrence M. Hurwitz, License #12202, t/a Broadway Electrical Company, Inc., stating that his assistant renewed his license; however, Mr. Hurwitz has not taken the required continuing education courses. Mr. Hurwitz has provided medical documentation regarding his medical condition.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Hurwitz asking him if his medical condition precludes him from carrying out the functions of his electrical contracting company. The Board would also like to know when Mr. Hurwitz started treatment for his medical condition; did he complete any continuing education courses; and whether or not there are any jobs pending in the State of New Jersey and if so, is he supervising any jobs in the State of New Jersey.

The Board discussed the installation of CSST (corrugated stainless steel tubing) gas piping.

After a brief discussion, the Board requested that this matter be discussed further at it's meeting to be held on May 2, 2012.

Signed cease and desist agreements were received from George Kennedy, Delaware Valley Signs, Tabernacle, New Jersey and Peter Monteleone, Hamilton, New Jersey.

The Board accepted the signed cease and desist agreements.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Thirteen (13) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
